Amendment to the Tamil Nadu Motor Vehicles Rules.

In exercise of the powers conferred by Sections 95 and 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Motor Vehicles Rules, 1989, the draft of the same having been previously published, as required by sub-section (1) of Section 212 of the said Act.

AMENDMENT

In the said Rules, to Rule 227, the following proviso shall be added, namely:-

"Provided that a stage carriage of State Transport Undertaking may be used in a public place without conductor, if tickets are issued before the commencement of the journey by any self-sustaining mechanism set up for this purpose or by any other means or by a person who is not a traveller in the vehicle".

In exercise of the powers conferred by Section 12 of the Tamil Nadu Industrial Establishments (National, Festival and Special Holidays) Act, 1958 (Tamil Nadu Act XXXIII of 1958), the Governor of Tamil Nadu hereby makes the following amedments to the Tamil Nadu Industrial Establishments (National and Festival Holidays) Rules, 1959, namely:-

AMENDMENTS

In the said Rules,-

- 1. for the expression "National and Festival Holidays" wherever it occurs, the expression "National, Festival and Special Holidays" shall be substituted;
 - 2. in rule 8, for the expression "fifty rupees", the expression "five thousand rupees" shall be substituted.
