

Whereas, vacancies, have arisen in the Syndicate under Sec. 22(2), Class-II (b) and (j) under Chapter IV of the Tamil Nadu Dr. Ambedkar Law University Act, 1996 and which shall be filled up by election from among the members of the Academic Senate in the manner prescribed below:-
