#### Amendment to the Fundamental Rules.

[G.O. Ms. No. 40, Personnel and Administrative Reforms (FR-II), 7th May 2019, சித்திரை 24, விகாரி, கிருவள்ளுவர் ஆண்டு–2050.]

No. SRO B-38/2019.—In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to Rule 9-A of the Fundamental Rules.

2. The amendment hereby made shall be deemed to have come into force on the 1st January 2006.

#### **AMENDMENT**

In the said Fundamental Rules, in rule 9-A, for the expression starting with "Group -A" and ending with "Rs.2,610.", the following expression shall be substituted, namely:-

- Group 'A'— Government Servants in posts drawing Grade Pay of Rs.6,600/- and above;
- Group 'B'— Government Servants in posts drawing Grade Pay of Rs.4,400/- and above, but below Rs.6,600/-
- Group 'C'— Government Servants in posts drawing Grade Pay of Rs.1,400/- and above, but below Rs.4,400/-;
- Group 'D'— Government Servants in posts drawing Grade Pay of Rs.1,300/-.".

No. SRO B-39/2019.—In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to Rule 9-A of the Fundamental Rules.

2. The amendments hereby made shall be deemed to have come into force on the 1st January 2016.

#### **AMENDMENT**

In the said Fundamental Rules, in rule 9-A, for the expression starting with "Group -A" and ending with "Rs.1,300/-.", the following expression shall be substituted, namely:-

- **Group 'A'** Government Servants in posts having pay levels from 25 to 32 drawing the pay of Rs.59,300 Rs.1,87,700 to Rs.1,28,900, Rs.2,25,000;
- **Group 'B'** Government Servants in posts having pay levels from 13 to 24 drawing the pay of Rs.35,900 Rs.1,13,500 to Rs.57,700, Rs.1,82,400;
- **Group 'C'** Government Servants in posts having pay levels from 2 to 12 drawing the pay of Rs.15,900 Rs.50,400 to Rs.35,600, Rs.1,12,800;
- Group 'D'— Government Servants in posts having pay level 1 drawing the pay of Rs.15,700-Rs.50,000/-.".

Framing of Adhoc Rules for the Temporary Post of Art Gallery Demonstrator in the Government College of Fine Arts in Department of Art and Culture in Tamil Nadu General Subordinate Service.

No. SRO B-41/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

2. The rules hereby made shall be deemed to have come into force on and from the 6th September 2006.

#### Rules

The General and the Special Rules applicable to the holders of the permanent posts in the Tamil Nadu General Subordinate Service shall apply to the holders of the temporary post of Art Gallery Demonstrator sanctioned from time to time, in the Department of Tourism, Culture and Religious Endowments subject to the modifications specified in the following rules.

Provided that on and from the 15th September 2016, the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of permanent posts in the Tamil Nadu General Subordinate Service shall apply to the holders of the aforesaid post.-

- Constitution.- The post shall constitute a distinct category in Class II of the said service.
- Appointment.- Appointment to the post specified in column (1) of the Table below shall be made by the methods specified in the corresponding entries in column (2) thereof;
