(ii) The dearness allowance shall be calculated on the first April of every year on the basis of the average of the indices for the preceeding twelve months, that is from January to December.

(iii) The first calculation shall be effective from the date of publication of this Notification in the *Tamil Nadu Government Gazette* based on the Average Chennai City Consumer Price Index Number for the previous year.

(3) (i) To arrive at the daily rate of wages, the monthly rate of wages shall be divided by 26.

(ii) To arrive at the monthly rate of wages, the daily rate of wages shall be multiplied by 30.

(4) Where the nature of work is the same, no distinction in the payment of wages shall be made in the case of male and female employees.

(5) Wherever the existing wages are higher than the minimum wages fixed herein, the existing wages shall be continued to be paid.

Order:—G.O.Ms. No. 80, Planning, Development and Special Initiatives (DB) 3rd June 2019

The Seventh Economic Census wholly financed by Government of India through Central Statistical Office is proposed to be conducted through State Governments/ Union Territories during the year 2019. The field work of the Seventh Economic Census is expected to be conducted in July 2019 and slated to be completed in three months time. The enumeration work for the 7th Economic Census will be carried out by Common Service Centre (CSC), Field Operations Division (FOD) of NSSO and State Government UTs have been entrusted with the responsibility of supervising the enumeration work carried out by CSC on sample basis, in the designated information Technology Platform using Officers/Staff of Department of Economics and Statistics, Department of Industries and Commerce and Micro, Small and Medium Enterprises - Development Institute.

2. During the enumeration work, each and every household in the urban and rural areas would be enumerated to capture the information on all household enterprises/own account enterprises within fixed premises or without fixed premises, as well as other public and private establishment in the State which aims to provide a frame of all establishments engaged in various economic activities both in organized and unorganized sectors of the Tamil Nadu economy.

3. The Ministry of Statistics and Programme Implementation, Government of India in the letter second read above has stated that a broad framework for implementation of the 7th Economic Census has been firmed up and therefore requested to constitute a State Level Co-ordination Committee and a District Level Co-ordination Committee which would provide necessary support for the activities of the 7th Economic Census in the State.

4. The Government accordingly decided to constitute the State Level Co-ordination Committee under the Chairmanship of Chief Secretary to Government, District Level Co-ordination Committee (other than Chennai) under the Chairmanship of District Collector and Co-ordination Committee for Greater Chennai Corporation, under the Chairmanship of Commissioner, Greater Chennai Corporation as detailed below for the smooth conduct of Seventh Economic Census during the year 2019.

1. Chief Secretary to Government of Tamil Nadu - Chairman
