### PERSONNEL AND ADMINISTRATIVE REFORMS DEPARTMENT

#### **Amendment to the Special Rules for the Tamil Nadu Secretariat Service.**

[G.O. Ms. No. 70, Personnel and Administrative Reforms (D), 14th June 2019,

No. SRO B-45/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Secretariat Service (Section 29 in Volume III of the Tamil Nadu Service Manual, 2016):-

2. The amendment hereby made shall be deemed to have come into force on the 1st August 2016.

#### AMENDMENT

In the said Special Rules, in rule 14, in the "TABLE", against the entry, "Category 3(d): Assistants in Finance Department" in column (1) and the corresponding entry "Recruitment by transfer from the post of Junior Assistant or Assistant in the Tamil Nadu Ministerial Service or Tamil Nadu Judicial Ministerial Service" in column (2) thereof, in column (3), in item (ii), for the expression "not less than five years", the expression "not less than three years" shall be substituted.

#### **Amendments to the Special Rules for the Tamil Nadu Ministerial Service.**

No. SRO B-46/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume III of the Tamil Nadu Services Manual, 2016).

2. The amendments hereby made shall be deemed to have come into force on the 19th January 2018.

#### AMENDMENTS

In the said Special Rules,—

- (1) in rule 35, in sub-rule(ab), after the proviso, the following proviso shall be added, namely:-

"Provided further that on and from the 19th January 2018, a person with the disability of 100% blindness or 100% deafness and appointed as Assistant by promotion from the post of Typist or by transfer from the post of Steno-typist, Grade-III, need not undergo the said Foundational Training.";

- (2) in Annexure-V, under the heading, "Tests to be passed, training to be undergone or other qualifications to be acquired by persons appointed to the service:", in the tabular column,—

- (i) in item No.8, after the third proviso, the following proviso shall be added, namely:-

"Provided also that on and from the 19th January 2018, a person with the disability of 100% blindness or 100% deafness and appointed as Junior Assistant by direct recruitment, need not undergo the said Foundational Training.";

- (ii) in item No.8A, after the proviso, the following proviso shall be added, namely:-

"Provided further that on and from the 19th January 2018, a person with the disability of 100% blindness or 100% deafness and appointed as Junior Assistant or Junior Assistant-cum-Typist by recruitment by transfer, need not undergo the above Foundational Training.";

- (iii) in item No.8B, after the proviso, the following proviso shall be added, namely:-

"Provided further that on and from the 19th January 2018, a person with the disability of 100% blindness or 100% deafness and appointed as Junior Assistant by transfer from the post of Telephone Operator or Telex Operator or Typist, need not undergo the above Foundational Training."; and

- (iv) in item No.9, the following proviso shall be added, namely:-

"Provided that on and from the 19th January 2018, a person with the disability of 100% blindness or 100% deafness and appointed as Assistant by direct recruitment, need not undergo the said Foundational Training."
