Amendments to the Adhoc Rules relating to the Temporary Post of Librarian Grade-I in Public Libraries Department in Tamil Nadu Educational Subordinate Service.

No. SRO B-53/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following amendments to the Adhoc Rules published with the School Education Department Notification No. SRO B-28/2006 in the *Tamil Nadu Government Gazette* Part-III-Section 1(b), dated the 17th May 2006 at Pages 38 to 55.

2. The Amendments hereby made shall be deemed to have come into force on the 3rd October 2007.

AMENDMENTS.

In the said rule.-

(i) in rule 3, in the Table, under Class I, for the expression "who have completed the age of 55 years," in item (i) in column (2), against the category "Librarian Grade-I" in column (1), the expression "who have put minimum 3 years of service in the post of Librarian Grade-II," shall be substituted;

(ii) In rule 5, in sub-rule (b), in the Table, under Class I, for the entries in item (ii) in Column (3) against the category "Librarian Grade-I" in column (1) and the corresponding entry "by promotion from Non-Graduates," in column (2) thereof, the following entries shall be substituted, namely:-

"(ii) minimum 3 years of experience in the post of Librarian Grade-II"
