Amendment to the Tamil Nadu Public Service Commission Regulations.

[G.O. Ms. No. 112, Personnel and Administrative Reforms (M), 6th August 2019, ஆடி 21, விகாரி, திருவள்ளுவர் ஆண்டு–2050.]

No. SRO B-56/2019.—In exercise of the powers conferred by the proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Public Service Commission Regulations, 1954 (Volume-I of the Tamil Nadu Services Manual, 1987):-

2. The amendment hereby made shall be deemed to have come into force on 26th February 2018.

#### AMENDMENT

In the said Regulations, in ANNEXURE I-A referred to in clause (b) of regulation 16, under the heading "A STATE SERVICES", after the entry "141. Senior Manager in the State Intelligence wing of Police Department", the following entry shall be added, namely:-

"142. Liaison Officer, State Guest House, Chepauk, Chennai".

#### AMENDMENT

In the said Regulations, in ANNEXURE I-A, under the heading "B. SUBORDINATE SERVICES", in clause 3, in item (XL),—

- (1) the expression "B.T. Assistants and Tamil Pandit, Grade-I" shall be omitted;
- (2) for of the expression "Department of Approved Schools and Vigilance Service", the expression "Department of Social Defence" shall be substituted.
