Framing of Adhoc Rules Relating to Post of Joint Director (Administration) in the Office of the Director of Survey and Land Records Department.

No. SRO B-64/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following rules:—

2. The rules hereby made shall be deemed to have come into force on the 26th June 2012.

RULES.

The General and the Special Rules applicable to the holders of the permanent posts in the Tamil Nadu General Service shall apply to the holders of the temporary post of Joint Director (Administration) in the Survey and Land Records Department, Subject to the modifications specified in the following rules, namely:—

- 2. Constitution:- The post shall constitute a separate category in the said service.
- 3. **Appointment:-** Appointment to the post shall be made by promotion from among the holders of the post of Deputy Director (Administration) in the Survey and Land Records Department.
- 4. **Pay:-** There shall be paid to the holder of the post, a monthly pay calculated in the Pay Band and Grade Pay of Rs.15600-39100 + Grade Pay 7600.

Amendments to the Special Rules for the Tamil Nadu Motor Vehicles Maintenance Subordinate Service.

[G.O. Ms. No. 140, Transport (H1), 19th August 2019, ஆவணி 2, விகாரி, திருவள்ளுவர் ஆண்டு–2050.]

No. SRO B-65/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu, hereby makes the following amendments to the Special Rules for the Tamil Nadu Motor Vehicles Maintenance Subordinate Service (Section 39 of Part III-B in Volume-III of the Tamil Nadu Services Manual, 2016).

- 2. (i) The amendment (1) hereby made shall be deemed to have come into force with effect on and from the 21st September 1999.
- (ii) The amendment (2) hereby made shall be deemed to have come into force with effect from the 15th September 2016.

AMENDMENTS.

In the said Special Rules.—

- (1) for rule 5, the following rule shall be substituted, namely.-
- 5. Rule of reservation. "The General Rule 22 of the Tamil Nadu State and subordinate Services Rules relating to reservation of appointment shall apply for appointment to all categories by the method of direct recruitment wherever the sanctioned strength is more than one in each category";
- 2) in rule 5, so amended for the expression "The General Rule 22 of the Tamil Nadu State and Subrodinate Services Rules" the following expressions shall be substituted, namely:-

"Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act,2016"
