#### Amendments to the Special Rules for the Tamil Nadu Government Press Subordinate Service.

[G.O. Ms. No. 101, Tamil Development and Information (S&P1-1), 17th September 2019,

No. SRO B-82/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Government Press Subordinate Service under Part III B, (Section 14 in Volume III of the Tamil Nadu Services Manual, 2016).

2. (i) The amendments (1), (2)(a), (b) hereby made shall be deemed to have come into force on and from the 27th October, 1979.

(ii) The amendments (2)(c) hereby made shall come into force on the date of publication of this Notification.

#### AMENDMENTS.

In the said Rules,

(1) in rule (1), under the heading "Class III Machine", for Categories "(7) Senior Machine Minder" and "(8) Junior Machine Minder", the Category " (7) Machine Minder" shall be substituted;

(2) In the Annexure (referred to in rules 2 and 4(b), in the Table, under the heading "CLASS III - MACHINE",-

(a) for the entries "Senior Machine Minder and Junior Machine Minder" in column (2) and the entry "Senior Machine Minder or Junior Machine Minder" in column (3) against the entry "(4) Computer (Machine)" in column (1) thereof, the entry "Machine Minder" shall, respectively, be substituted;

(b) for the entry, "Senior Machine Minder" in columns (2) and (3) against the entry "(6) Machine operator" in column (1) thereof, the entry "Machine Minder" shall, respectively, be substituted;

(c) for the categories "(7) Senior Machine Minder" and "(8) Junior Machine Minder" in column (1) and the entries relating thereto in columns (2) and (3) thereof, the following Categories and entries shall, respectively, be substituted, namely:-

"(7) Machine Minder	By direct recruitment	(1)	Must have passed the S.S.L.C. examination or its equivalent; and
		(2)	Must possess the appropriate Technical Trade Certificate from any of the institutions approved and recognized by the Government or must have put a minimum period of apprenticeship prescribed under Apprenticeship Act, 1961 (Central LII of 1961):

Provided that other things being equal, preference shall be given in the following order:-

- (i) Candidates who have undergone Apprentice training in any of the Government Press and possess the requisite educational and technical qualifications;
- (ii) Candidates who have undergone Apprentice Training in any of the Government Press and possess the requisite educational qualification, but do not possess the prescribed technical qualification and qualified in the Trade Test in the relevant field conducted by the Director of Stationery and Printing, Chennai.
- (iii) Mazdoors below thirty five years of age who have served for a period of not less than two years in Government and Press and who possess requisite educational technical qualification.
- (iv) Others possessing the required educational and technical qualifications."
