## Amendment to the Special Rules for the Tamil Nadu Treasuries and Accounts Subordinate Service.

[G.O. Ms. No. 293, Finance (T & A-II), 18th September 2019, புரட்டாசி 1, விகாரி, திருவள்ளுவர் ஆண்டு–2050.]

No. SRO B-85/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Treasuries and Accounts Subordinate Service (Section 31-A in Volume III of the Tamil Nadu Services Manual, 2016).

2. The amendment hereby made shall be deemed to have come into force on and from the 9th January 2013.

#### AMENDMENT.

In the said Special Rules, in rule 4, in the TABLE, in column (3), for the entries "(2) Must have undergone Sub-Treasury training for a period of six months", against the entry "Category 2" in column (1) and the corresponding entry "Promotion from among the holders of posts in Category 4" in column (2) thereof, the following entry shall be substituted, namely:-

(2) Must have served as Sub-Treasury Officer or Superintendent in a Sub-Treasury for a period of one year";

Amendments to the Adhoc Rules relating to the Posts of Professor and Associate Professor of Mathematics, Physics, Chemistry in the Government Engineering Colleges in Technical Education in Tamil Nadu Educational Service.

Ms. No. 216, Higher Education (B1) 12th September 2019, ஆவணி 26, விகாரி, திருவள்ளுவர் ஆண்டு–2050.] No. SRO B-87/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the adhoc rules issued with Notification I.SRO No. A 731 of 1964 published at pages 745-749 of Part V of the Fort St. George Gazette, dated the 22nd July 1964.

2. The amendments hereby made shall be deemed to have come into force on 04-01-2016.

# AMENDMENTS.

In the said rules, -

- (1) for rule 1, the following rule shall be substituted, namely:-
- "1. The provisions contained in the Tamil Nadu Government Servants/ (Conditions of Service) Act, 2016 and Special Rules applicable to the holders of the permanent post of Professor in category 2 of Class V in the Tamil Nadu Educational Service shall apply to the holders of the temporary post of Professor of Mathematics, Physics and Chemistry in Government Engineering Colleges subject to the modifications specified in the following rules.";
  - (2) for rule 3 and the provisos thereunder, the following rule shall be substituted, namely:-

- "3. APPOINTMENT.- Appointment to the post shall be made as follows:-
- (i) Promotion from the category of Associate Professor (Mathematics, Physics, Chemistry) in Government Engineering Colleges;
- (ii) If no qualified and suitable candidate is available for appointment by the method specified in item (i) above, by direct recruitment .";
  - (3) for rule 4 and the proviso thereunder, the following rule shall be substituted, namely:-
- "4. **AGE**.-No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete 57 years of age on the first day of July of the year in which the vacancy is notified.";
  - (4) for rule 5, the following rule shall be substituted, namely:-
- "5. **QUALIFICATIONS.-** No person shall be eligible for appointment to the post of Professor of Mathematics, Physics and Chemistry subjects in Government Engineering Colleges unless he possesses the qualifications prescribed in the table below:-

	(ii)	A minimum of 10 years of teaching experience in University or College, and/or experience in research at the University or National level Institutions or Industries, out of which 5 years should be at the level of Associate Professor including experience of guiding candidates for research at doctoral level.

		Minimum of 13 years of teaching experience in University or College, and/or experience in research at the University or National level Institutions or Industries; and	
	(iii)	Evidence of published work with a minimum of 4 publications with good impact factor in International Journal of repute.
