HEALTH AND FAMILY WELFARE DEPARTMENT

Amendments to the Adhoc Rules relating to the Temporary post of District Extension Educator in the Family Welfare Programme in Tamil Nadu Medical Subordinate Service.

No. SRO B-4/2019.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Health and Family Welfare Department Notification SRO. No. B-232/91, published at page 181 of Part III-Section 1(b) of *Tamil Nadu Government Gazette*, dated the 11th September 1991, as subsequently amended.

2. The amendments shall come into force on and from the date of issue of this order.

AMENDMENTS

In the said Rules,

(1) in rule 3 sub-rule (a) (i) the following rule shall be substituted, namely:-

3. Appointment

Appointment to the post shall be made as follows:-

(a) (i) by promotion from the category of Block Health Statistician; or

(2) In rule 5, in sub-rule (b), for the Table, the following Table shall be substituted, namely:-

<i>Method of appointment</i> (1)	<i>Qualification</i> (2)
(i) Promotion	(i) A Degree; (ii) Three months certificate course in Information Education and Communication within a period of Two years from the date of joining in the promotional post of District Extension Educator as post requisite qualification with experience for a period not less than fifteen years;
(ii) Recruitment by transfer	(i) A Degree; (ii) Three months certificate course in Information Education and Communication with experience for a period of not less than five years in the respective post; or Post Graduate Diploma in Health Promotion and Education with experience for a period not less than two years in the respective post;
(iii) Direct recruitment	Post Graduate degree in Sociology;

(3) In rule 8, the following shall be added namely:-

(c) every person appointed to the post by promotion shall complete Three Months Certificate Course in IEC within a period of two years from the date of his joining duty failing which his increment shall be stopped without, cumulative effect till he complete the said course.

Provided that a person who has already completed the Three Months Certificate Course in IEC need not complete the said course.

3. Saving clause:

Nothing contained in these rules shall adversely affect the person who holds the post on the date of issue of these rules.

Amendment to Adhoc Rules relating to the Temporary Post of Deputy Director (Demography) in Tamil Nadu Medical Service

No. SRO B-5/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Health and Family Welfare Department Notification No. SRO. B-84/93, at pages 81-82 of Part III-Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 2nd June 1993.

2. (i) The amendment (1) hereby made shall be deemed to have come into force on the **thirty first day of October 2013**.

(ii) The amendment (2) hereby made shall take notional effect from 01-01-2006 for the purpose of fixation of pay in the revised scale of pay with monetary benefit from 01-04-2013.

AMENDMENT

In the said Rules,-

- (1) in rule 1 for the expression "Demographer," the expression "Deputy Director (Demography) shall be substituted;
(2) for rule 7, the following rule shall be substituted, namely:-

"7. There shall be paid to the holders of the post a monthly pay calculated in the pay band of Rs.15600-39100 with Grade pay of Rs.6600".

Amendments to the Special Rules for the Tamil Nadu Industries Service

[G.O. Ms. No. 1, Micro, Small and Medium Enterprises [E1(1)], 3rd January 2019,

No. SRO B-6/2019.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Industries Service (Section 19 of Part III of the Special Rules for the State Services in Volume II of Tamil Nadu Service Manual, 2016).

2. The amendments hereby made shall come into force on the 3rd January, 2019.

AMENDMENTS

In the said Rules,-

(1) in rule 2, in sub-rule (a), for item (1) including the proviso and other provisions thereunder, in column 2 and the proviso against the entry 'Assistant Director of Industries and Commerce, Chief Instructor, Technical Training Centre, Guindy; Assistant Superintendent, Central Electrical Testing Laboratory, Kakkalur; Principal, Institute of Tool Engineering, Dindigul', in column (1) under the heading posts, the following item shall be substituted, namely,--

"1. Recruitment by transfer from among the holders of the posts of Assistant Engineer (Industries) and Junior Engineer (Industries) in the Tamil Nadu Industries Subordinate Service shall be made to the posts of Assistant Director of Industries and Commerce and other interchangeable posts and a ratio of 3:1 shall be maintained to such appointment by recruitment by transfer from Assistant Engineer (Industries) and Junior Engineer (Industries)".-

(2) In the Annexure (referred to in rule 4 (b), for the existing entries in column (2) and the Corresponding entries relating thereto in column (3) thereof, against the entry 'Assistant Director of Industries and Commerce, Chief Instructor, Technical Training Centre, Guindy, Assistant Superintendent, CETL, Kakkalur and Principal Institute of Tool Engineering, Dindigul' - in column (1), the following entries shall respectively, be substituted, namely:-

"Recruitment by transfer from among the holders of the posts of Assistant Engineer (Industries) and Junior Engineer (Industries) in the Tamil Nadu Industries Subordinate Service.

"Must possess a Bachelor of Engineering / Bachelor of Technology / Diploma of any discipline except Civil Engineering and Architectural Engineering awarded by any University recognized by the University Grants Commission or Institution recognized by the All India Council for Technical Education in case of degree holders and State Board of Technical Education and Training, Tamil Nadu or a recognized Institution or Board in case of Diploma holders respectively".

Provided that on and from 01-04-1978, in case of degree holders, he must have served for period of not less than 5 years as Assistant Engineer (Industries) in the Tamil Nadu Industries Subordinate Service and in case of Diploma holders, he must have served for a period of not less than seven years as Junior Engineer (Industries) in the Tamil Nadu Industries Subordinate Service.

Direct recruitment

(1) Must possess a Bachelor of Engineering or Bachelor of Technology degree of any discipline except Civil Engineering and Architectural Engineering of any University recognized by the University Grants Commission or Institution recognized by the All India Council for Technical Education.

(2) Practical experience in a Factory or Workshop for a period of not less than one year.

Amendment to Fundamental Rules

No. SRO B-7/2019.— In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment of the Fundamental Rules:-

2. The amendment hereby made shall be deemed to have come into force on the 1st January, 2016.

AMENDMENT

In the said Fundamental Rules, in rule 9, in sub-rule (21) (a), in clause (i), for the expression "the pay drawn in the prescribed pay band plus the applicable grade pay", the expression "the pay drawn in the appropriate cell of the level as specified in the pay matrix" shall be substituted.
