In the said modified Master Plan in the "LAND USE SCHEDULE" under the heading V.No: 34, "SINDALAGUNDU EAST VILLAGE "

(1) Against the entry for the expression 'Industrial' (General) use the comprising SF No: 664 to 666 shall be changed as 664 to 666 ( except 665/5,6,7).

(2) Against the entry for the expression to Agriculture use the comprising SF No: 658, 687 to 695, shall be changed as 658 (except 658/1A,658/1B,658/1C,658/1D) and 687 to 695 (except 689/1A1, 689/1B).

(3) Against the entry for the expression under Educational Use Zone (Institutional) 658/1A,1B,1C,1D, 665/5,6,7, 689/1A1, 689/1B Shall be added.
