No. SRO B-9/2019.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Ad-hoc Rules published with the Health and Family Planning Department Notification No. SRO. B-199/74 at Pages 198-212 of Part III-Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 8th May 1974.

2. The amendment hereby made shall be deemed to have come into force on and from the 23rd November 1992.

No. SRO B-12/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules published with the Health and Family Welfare Department Notification No. SRO B.89/86, at Page 104 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 12th day of March 1986.

2. The amendment shall be deemed to have come into force on and from the 16th day of April 2009.

## AMENDMENT.

In the said Rules, in rule 5 for sub-rule (b), the following sub-rule shall be substituted namely:-

- "(b). No person shall be eligible for appointment to the post unless he possesses a Degree in Statistics or a Degree in Mathematics with Statistics as a special subject or having qualified in any one of the following subjects namely;-
- (i) Fundamental Statistics, Applied Statistics probability and Applied Statistics and Basic Statistics for actuarial Science.
  - (ii) Fundamental Statistics and Applied Statistics.
  - (iii) Applied Statistics only.
  - (iv) Probability and Applied Statistics.
  - (v) Practical Statistics and Statistics interference.".

- No. SRO B-13/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Public Health Service (Section 24 in Volume II of the Tamil Nadu Services Manual, 1969).
- 2. (i) The amendment (1) hereby made shall be deemed to have come into force on the 13th January 1981 remain in force upto and inclusive on the 5th April 1999.
  - (ii) The amendment (2) hereby made shall be deemed to have come into force on the 6th April 1999.

#### **AMENDMENTS**

In the said Rules, in rule 4, in sub-rule (1), in the TABLE, -

"Provided that preference shall be given to candidates who possess the qualification specified in item (ii)."

No. SRO B-14/2019.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Public Health Service (Section 24 in Volume II of the Tamil Nadu Services Manual, 1969).

- (c) Amendments (2) (ii) and (3) hereby made shall be deemed to have come into force on and from the 14th September 2016.
  - (d) Amendment (6) hereby made shall be deemed to have come into force on the 4th January 1989.
- (e) Amendments (4) (v), (5) and (7) hereby made shall come into force on and from the date of publication of the notification in the *Tamil Nadu Government Gazette*.

  - (2) in rule 2, -
    - (i) in the tabular columns, under Class-I, -
- (a) for category 2 in column (1) and the corresponding entry in column (2) thereof, the following entries shall, respectively, be substituted, namely:-

"2. Deputy Director of Public Health and Preventive Medicine, Deputy Director of the Health Unit Districts, Principals of the Regional Training Centres, Officer in-charge Orientation Training Centre, Poonamallee and Professor of Social and Preventive Medicine in Government Medical Colleges. by promotion from any of the posts in category 2C.";

- (b) after category 2B in column (1) and the corresponding entries in column (2) thereof, the following entries shall, respectively, be inserted, namely:-
  - "2C Deputy Director (Research) of the Directorate, Corporation Health Officers of Madurai and Coimbatore, Professor/Associate Professor in Community Medicine Departments of Medical Colleges.

by promotion from any of the posts in category 2D";

- (c) after category 2C in column (1) and the corresponding entries in column (2) as so inserted, the following entries shall, respectively, be inserted, namely:-
  - "2D Health Officer, Madras Medical College, Health Officer, Regional training centres, Filaria Officer at regional level, City Health Officers of the Municipal Corporations, Programme Health Officer, Health Officers of the Special Grade Municipalities

by promotion from any of the posts in category 3.";

- (d) for category 3 in column (1) and the corresponding entry in column (2) thereof, the following entries shall, respectively, be substituted, namely:-
  - "3. Health Officer, Regional Malarialogist, District Health Officer, Municipal Health Officer, Reserve Health Officer, Assistant District Health Officer, Assistant Municipal Health Officer, Research Health Officer, Nutrition Officer, Health Educator Training Officer, Assistant-in-charge Orientation Training Centre, Poonamallee, Assistant Professor of Social and Preventive Medicine in Medical Colleges, Programme Health Officer, Assistant City Health Officer in Municipal Corporations, Assistant Professor in Community Medicine Department and Research-cum-Action Project Health Officer.
- (i) by direct recruitment;
- (ii) by recruitment by transfer from among the holders of the post of Assistant Surgeon in the Tamil Nadu Medical Service:
- Provided that appointment by direct recruitment and recruitment by transfer shall be made in the ratio of 1:1.
- Provided further that if sufficient candidates are not available by direct recruitment, the unfilled vacancies shall be filled by recruitment by transfer and *vice-versa.*";
- (ii) the provisions at the end of the tabular columns shall be omitted.
- (3) for rule 3, the following rule shall be substituted, namely:-
- "3. **Reservation of appointments.** The provisions relating to reservation of appointments contained in Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) shall apply to the appointments to the posts included in category 3.";
  - (4) in rule 4, in sub-rule (1), in the TABLE, under Class-I,-
- (i) for category 2 in column (1) and the corresponding entries in columns (2) and (3) thereof, the following category and the entries relating thereto, shall, respectively, be substituted, namely:-

"2. Deputy Director of Public Health and Preventive Medicine, Deputy Director of the Health Unit Districts, Principals of the Regional Training Centres, Officer in charge Orientation Training Centre, Poonamallee and Professor of Social and Preventive Medicine in Governmet Medical Colleges. by promotion from any of the posts in category 2C

Must have completed not less than two years of service in any of the posts in category 2C.";

- (ii) after category 2B in column (1) and the corresponding entries in columns (2) and (3) thereof, the following category and the entries relating thereto shall, respectively, be inserted, namely:-
  - "2C. Deputy Director (Research) of the Directorate, Corporation Health Officers of Madurai and Coimbatore, Professor/Associate Professor in Community Medicine Departments of Medical Colleges.

by promotion from any of the posts in category

Must have completed not less than five years of service in any of the posts in category 2D.";

- (iii) after category 2C as so inserted in column (1) and the corresponding entries in columns (2) and (3) thereof, the following category and the entries relating thereto shall, respectively, be inserted, namely:-
  - "2D Health Officer at Madras Medical College, Health Officer in regional training centres, Filaria Officer at regional level, City Health Officers of the Municipal Corporations, Programme Health Officer, Health Officers working in the Special Grade Municipalities.

by promotion from any of the posts in category 3 Must have completed not less than six years of service in any one or more of the posts in category 3.";

- (iv) for category 3 in column (1) and the corresponding entries in columns (2) and (3) thereof, the following category and the entries relating thereto shall, respectively, be inserted, namely:-
  - "3. Health Officer, Regional Malarialogist, District Health Officer, Municipal Health Officer, Reserve Health Officer, Assistant District Health Officer, Assistant Municipal Health Officers, Research Health Officer, Nutrition Officer, Health Educator Training Officer, Assistant-in-charge Orientation Training Centre, Poonamallee, Assistant Professor of Social and Preventive Medicine in Medical Colleges, Programme Health Officer, Assistant City Health Officer in Municipal Corporations, Assistant Professor in Community Medicine Department and Research-cum-Action Project Health Officer.
- (i) by direct recruitment;
- (ii) by recruitment by transfer from among the holders of the post of Assistant Surgeon in the Tamil Nadu Medical Service.
- (a) Must not have completed or will not complete 35 years of age on the first day of July of the year in which the vacancy is notified:
- (b) Must possess MBBS degree awarded by the Tamil Nadu Dr. M.G.R. Medical University or by any other University recognized by the Medical Council of India;
- (c) Must be a Registered Medical Practitioner within the meaning of the Tamil Nadu Medical Registration Act, 1914 (Tamil Nadu Act IV of 1914);
- (d) Must possess diploma in Public Health awarded by the. Tamil Nadu Dr. M.G.R. Medical University, Chennai or by any other University recognized by the Medical Council of India; or

Must possess M.D. (Social and Preventive Medicine / Community Medicine) degree awarded by the Tamil Nadu Dr. M.G.R. Medical University, Chennai or by any other University recognized by the Medical Council of India; or

Must possess Diplomate of National Board in Community Health Medicine awarded by the National Board of Examination, New Delhi; or

Must possess Master of Public Health degree of any University recognized by the Medical Council of India:

Provided that, if candidates with the qualification specified in item (d) above are not available for appointment by direct recruitment, candidates who possess the qualifications specified in items (a), (b) and (c) may be appointed, subject to the following conditions, namely:-

- (i) They shall acquire the said qualification within the period of their probation. Failing which, the appointing authority shall forthwith, by order, terminate their probation and discharge them from service;
- (ii) They shall execute a bond, undertaking to serve the Government till they retire from service on attaining the age of superannuation:

Provided that one must have served for a period of not less than three years as Assistant Surgeon in the Tamil Nadu Medical Service for appointment by recruitment by transfer.";

- (v) the Note under category 3 shall be omitted;
- (5) in rule 5, before the first proviso, the following proviso shall be inserted, namely:-

"Provided that the period of probation for those appointed to any of the posts in category 3 by direct recruitment without possessing diploma in Public Health or MD. (Social and Preventive Medicine / Community Medicine or Diplomate of National Board in Community Health Medicine or Master of Public Health degree shall be four years on duty, within a continuous period of five years.";

(6) in rule 6, to clause (a), the following proviso shall be added, namely :-

"Provided that a person appointed as Health Officer by direct recruitment do not pass the Account Test for Executive Officers, within the period of his probation, he may be declared to have satisfactorily completed his probation in the said category, if he is found otherwise suitable, but his increments in the time scale of pay applicable to him shall be stopped without cumulative effect till he passes the said test.";

(7) after rule 9, the following rule shall be added, namely:-

**"10.** *Training.* - Every person appointed to any of the posts in category 3 shall undergo an Orientation Training Course in Public Health for a period of three months before their posting. During the period of training, he shall be paid the first cell in level 23 in the Pay Matrix, applicable to category-3."
