Constitution of a Separate District Munsif Court at Shencottah by converting the existing District Munsif-cum-Judicial Magistrate Court, Shencottah in Tirunelveli District.

Uploading Details of Students Completing UG/PG/Super Speciality/DNB/Fellowship Courses by Medical Universities/ Recognized institutions in the portal of Tamil Nadu Medical Council.

(Ref: TNMC/G.No. 102/2020, dated 21-02-2020)

In exercise of powers conferred by Section 11 of The Madras Registration Act, 1914, The Tamil Nadu Medical Council a Statutory Body constituted as a result of enactment of The Madras Registration Act, 1914 by the Government is vested with powers, duties and function of regulating the practice of Modern Scientific System of Medicine in Tamil Nadu, Puducherry, and Andaman and Nicobar Islands by providing for registration of medical practitioners and maintain a live register. In this regard, paperless, high secured Cloud based software for online Registration has been developed and put into use w.e.f. 6th January, 2020. This is user-friendly, safe and checks impersonation.

2. In the new Software the Medical Universities/Institutions are required to upload the data of all batches of Students doing UG/PG/Super Speciality Courses/Fellowship Courses in their institutions to the Portal of the Tamil Nadu Medical Council by using their Login-id. Tamil Nadu Medical Council will verify those details with individual details uploaded by the Applicants for registration and issue online Registration Certificates such as Provisional Registration for internship/UG Licentiate registration of MBBS/Registration for Additional qualifications.

3. Required training for uploading the data of the students in the portal of the Tamil Nadu Medical Council has been given to all Medical Colleges/ Institutions in batches by the Tamil Nadu Medical Council.

4. In exercise of powers vested in Section 21 of The Madras Registration Act, 1914, all Medical Universities/Medical Colleges/Institutions which are providing recognized Modern Medical Courses are hereby called upon to upload the details of Students of ALL BATCHES of MBBS/Post Graduate Degree/Diploma Courses/DNB Courses/Fellowship/Certificate a Super Specialty Courses as per the following schedule:-
