ORDER: G.O. Ms. No. 113, Home (Courts-I), 21st February 2020

The Registrar (Recruitment), High Court of Madras, in his letter third read above has stated that Tvl. G.Arjunan (Sl.No.48) and J.Praveen (Sl.No.59) provisionally selected candidates for the post of Civil Judge and appointed in the Government Order second cited, by direct recruitment, but have not joined their duty as they have taken alternative employment. He has further stated that when the above

intimations were placed before the Hon'ble Selection and Appointment Committee, the Registry of High Court of Madras, has been directed to inform the Government of Tamil Nadu and the Tamil Nadu Public Service Commission for appropriate action.

- 2. Further the Registrar (Recruitment), High Court of Madras, in his letter fourth read above, has stated that one Thiru. S.Balaji has informed that he was appointed to act temporarily as Civil Judge in the Tamil Nadu State Judicial Service in the Government Order 2nd read above and owing to his personal reasons, he has decided to resign from the said post and prayed to crave leave from the High Court of Madras and requested to treat it as his resignation letter, which was also placed before Hon'ble Selection and Appointment Committee and the Hon'ble Committee considered his request and accepted the same and further directed to inform Tamil Nadu Public Service Commission and the Government of Tamil Nadu about the decision of Thiru. S. Balaji (SI. No.10), Chennai.
- 3. Further the Registrar (Recruitment) in his D.O.Letter fifth read above, has stated among others, that while arriving the estimated vacancies of 176 posts as on 6-6-2019, the abovesaid 3 unfilled vacancies of Tvl. G.Arjunan (Sl.No48), J.Praveen (Sl.No.59) and S. Balaji (Sl.No.10) who have not joined duty, was included. The Secretary, Tamil Nadu Public Service Commission, Chennai, in his letter seventh read above, has also accorded its concurrence for the removal of the names of the candidates *viz.*, Tvl. S.Balaji (Sl-No 10), G.Arjunan (Sl.No.48) and J.Praveen (Sl.No.59) and requested to issue formal orders removing of their names from the approved list of candidates selected provisionally for appointment by direct recruitment to the post of Civil Judge in the Tamil Nadu State Judicial Service for the years 2014-2015 to 2016-2017.
- 4. The Government, after careful examination, have decided to accept the request of the Secretary, Tamil Nadu Public Service Commission, Chennai. Accordingly, the Government hereby remove the names of the candidates *viz.*, Tvl. S.Balaji (SI.No.10), G.Arjunan (SI.No.48) and J.Praveen (SI.No.59), from the list of approved candidates selected provisionally for appointment by direct recruitment to the post of Civil Judge in the Tamil Nadu State Judicial Service for the years 2014-2015 to 2016-2017, issued in G.O.4D.No.56, Home Department, dated 28-12-2018.
