Amendments to the Ad hoc Rules for the Change of nomenclature of the temporary post of Personal Assistant to Assistant Commissioner of Civil Supplies as Manager in Civil Supplies and Consumer Protection Department in Tamil Nadu Ministerial Service.

No. SRO B-14/2020.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Ad hoc Rules published with the Food Department Notification No.SRO B-175-78, at pages 185-187, in Part-III-Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 26th April 1978.

2. (a) Amendments 1(i) and 2(i) hereby made shall be deemed to have come into force on the 28th March, 2001.

(b) Amendments 1(ii) and 2(ii) hereby made shall be deemed to have come into force on the 12th April, 2016.

- (c) Amendment 2(iii) hereby made shall be deemed to have come into force on the 15th September, 2016.
- (d) Amendment (3) hereby made shall be deemed to have come into force on the 1st January, 2016.

AMENDMENTS.

In the said Special Rules,-

1. in the preamble, in the tabular column,-

(i) for the expression "8. Personal Assistant to Commissioner of Civil Supplies" in column (1) against the corresponding entries in column (2) and column (3) thereof, the following expression shall be substituted, namely:-

"8. Administrative Officer".;

(ii) for the expression "8. Administrative Officer" as so substituted, the following expression shall be substituted, namely:-

"8. Manager".;

2. in rule (1),-

(i) for the expression "8.Personal Assistant to Assistant Commissioner of Civil Supplies", the expression "Administrative Officer" shall be substituted;

- (ii) for the expression "8. Administrative Officer" as so substituted, the expression "Manager" shall be substituted;
- (iii) the following proviso shall be inserted, namely;

"Provided that with effect on and from the 15th September 2016, the provisions contained in the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to holders of the permanent posts in the Tamil Nadu Ministerial Service shall apply to the holder of the post".

3. to rule 6, the following proviso shall be inserted, namely;

"Provided that with effect on and from the 1st January 2016, a monthly pay shall be calculated in Level 20 - Rs.37700 - 119500/- under the Tamil Nadu Revised Pay Rules, 2017".
