Amendments to the Special Rules for the Tamil Nadu Engineering Subordinate Service.

No. SRO B-15/2020.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Engineering Subordinate Service (Section 8 in Volume III of the Tamil Nadu Services Manual, 2016):-

AMENDMENTS.

In the said Special Rules, in Part II, under the heading "Branch I - Engineering Branch",-

- (1) in rule 2, in sub-rule (a),-
- (i) for the entries in column (2) against the entries under category 4(a), "(iii) Junior Draughting Officer" in column (1) thereof, the following entries shall be substituted, namely:-
 - "(i) by direct recruitment; or
 - (ii) by promotion from Assistant Draughtsman; or
 - (iii) by promotion from the category of Work Inspector in Branch XII; or
 - (iv) by promotion from the category of Irrigation Inspector in Branch III:

Provided that fifty percent (50%) of the substantive vacancies arising in the post of Junior Draughting Officer during a year shall be filled up by direct recruitment through Tamil Nadu Public Service Commission and the remaining fifty percent (50%) of the vacancies shall be filled up by other methods as follows:-

(a) by promotion from Assistant Draughtsman 40%(b) by promotion from Work Inspector 8%(c) by promotion from Irrigation Inspector 2%

Provided further that if, sufficient number of qualified and suitable persons are not available for appointment by any one of the methods mentioned above, the unfilled vacancies shall be filled up by the method of direct recruitment";

- (ii) for the entries, in column (2) against the entries under category 6, "Assistant Draughtsman" in column (1) thereof, the following entries shall be substituted, namely:-
 - "(i) by direct recruitment; or
 - (ii) by promotion or transfer from any other category; or
 - (iii) by recruitment by transfer from any other service:

Provided that seventy percent (70%) of the substantive vacancies arising in the post of Assistant Draughtsman during a year shall be filled up by direct recruitment through Tamil Nadu Public Service Commission and the remaining thirty percent (30%) of the vacancies shall be filled up by other methods as follows:—

(a) by promotion or transfer from any category 20%

(b) by recruitment by transfer from any other service 10%

Provided further that if sufficient number of qualified and suitable persons are not available for appointment by any one of the methods mentioned above, the unfilled vacancies shall be filled up by the method of direct recruitment".

- (2) in schedule II, referred to in rule 6,-
 - (i) for the entries (i) & (ii) in column (2), against the entries "Special Grade Draughting Officer, Senior Draughting Officer, Draughting Officer and Junior Draughting Officer" in column (1) thereof, the following entries shall be substituted, namely:-
 - "(i) Diploma in Civil Engineering awarded by the State Board of Technical Education and Training, Tamil Nadu or its equivalent qualification recognized by the Director General of Employment and Training, Government of India or by the All India Council for Technical Education; or
 - (ii) Diploma in Architectural Assistantship awarded by the State Board of Technical Education and Training, Tamil Nadu or its equivalent qualification recognized by the Director General of Employment and Training, Government of India or by the All India Council for Technical Education";
 - (ii) after the second proviso in column (2), against the entries "Special Grade Draughting Officer, Senior Draughting Officer, Draughting Officer and Junior Draughting Officer" in column (1) thereof, the following proviso shall be added, namely:-

"Provided also that except Assistant Draughtsman, the persons working as Work Inspector, Irrigation Inspector in Tamil Nadu Engineering Subordinate Service must have rendered service for not less than five years in that respective category.";

(iii) after the entries in column (2), against the entry "Assistant Draughtsman" in column (1) thereof, the following proviso shall be added, namely:-

"Provided that the persons who have been considered for appointment as Assistant Draughtsman by promotion or transfer or recruitment by transfer must have rendered service for not less than five years in a particular service."
