## NOTE:

1. As Republic Day (26-01-2020), Bakrid (01-08-2020), Independence Day (15-08-2020), Vinayakar Chathurthi (22-08-2020), Muharram (30-08-2020), Ayutha Pooja (25-10-2020) and Deepavali (14-11-2020) fall on Saturdays / Sundays, these are not shown in the above list.

2. The Saturdays falling on 04-01-2020, 01-02-2020, 07-03-2020, 25-04-2020, 06-06-2020, 04-07-2020, 05-09-2020, 07-11-2020, 21-11-2020 and 05-12-2020 are fixed as working days for the Subordinate Courts. Except the above Saturdays, all other Saturdays and Sundays are holidays.

3. The office of the Part Time official receiver, Tiruchirappalli which is having the jurisdiction over Pudukkottai District will remain open throughout the periods of adjournments.

6. The Offices for other sections will remain opened for:-

- furnishing necessary records to the Copyists and Process Service Establishments.
- transmitting the records to the Appellate Courts for appeal etc.,

The Vacation Civil Judge, who will be appointed by the Government for the District of Pudukkottai Under Section 30 of the Tamil Nadu Civil Courts Act (Central Act III of 1873), as amended by Sec.4 of the Tamil Nadu Act 17 of 1959, will attend the disposal of urgent Civil work during Summer Vacation 2020, Civil Suits, Appeals and proceedings in Civil Cases alone will be received and disposed off by him in terms of Section 30(c) of the above said Act and the rules.

**Constitution of a District Munsif Court at Alangulam in Tirunelveli District**

In exercise of the powers conferred by Section 5 of the Tamil Nadu Civil Courts, Act, 1873 (Central Act III of 1873) the High Court, Madras, hereby fixes Alangulam in Tirunelveli District as the place at which the District Munsif Court, Alangulam, shall be located.

In exercise of the powers conferred by Section 11 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) the High Court, Madras, hereby directs that in Tirunelveli District, the Principal District Munsif Court, Ambasamudram shall cease to have local jurisdiction over Kuthapanjan Village in Puthupatti Firka and entire Vengadampatti Firka of Alangulam Taluk; the District Munsif-cum-Judicial Magistrate Court, Cheranmahadevi shall cease to have local jurisdiction over entire Puthupatti Firka ((except Kuthapanjan Village) of Alangulam Taluk and the District Munsif Court, Tenkasi shall cease to have local jurisdiction over entire Nettur Firka, Alangulam Firka and Keelapavoor Firka of Alangulam Taluk and the District Munsif Court, Alangulam shall have and exercise local jurisdiction over the entire Taluk of Alangulam with effect from the date on which the District Munsif, Alangulam assumes charge of that Court.
