ORDER: No. 827, Public (Protocol-III), 28th February 2020

In the G.O. first read above, Major APS Rathore (IC-75630) from Indian Army was appointed as Aide-de-Camp (Army) to Hon'ble Governor of Tamil Nadu on deputation basis for a period of two years with effect from 9-2-2018 FN on the terms and conditions of the services intimated by Indian Army, New Delhi and his tenure expired on 8-2-2020. Now, Ministry of Defence, New Delhi, has stated that the Competent Authority

has approved the extension of tenure of IC-75817N Major Ajay PS Rathore, ADC to Governor of Tamil Nadu for four months beyond 9-2-2020 and has requested to issue necessary orders immediately under intimation to MoD. In the letter second read above the Deputy Secretary to Governor and Comptroller, Raj Bhavan, Chennai, has requested the Government to issue necessary orders for extending the tenure of Major Ajay PS Rathore, ADC to Hon'ble Governor of Tamil Nadu for four months beyond 9-2-2020.

The Government is hereby accord sanction for extension of the deputation tenure of Major APS Rathore (IC-75817N) from Indian Army as Aide-de-Camp to Hon'ble Governor of Tamil Nadu for a further period of four months with effect from 9-2-2020 under the existing terms and conditions issued *vide* G.O.Ms. No. 370, Public (Protocol.III) Department, dated 24-5-2018.
