Adhoc Rules relating to the Temporary posts of Assistant Scientific Officer (Chemistry), Assistant Scientific Officer (Microbiology) and Assistant Scientific Officer (Pharmacognosy) in Indian Medicine and Homoeopathy in Tamil Nadu Medical Subordinate Service.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

2. The Rules hereby made shall be deemed to have come into force on and from the 12th February 2016.

Rules

The General Rules for the Tamil Nadu State and Subordinate Service and the Special Rules applicable to the holders of the permanent post in Branch-I – Medical of the Tamil Nadu Medical Subordinate Service shall apply to the holder of the temporary post sanctioned from time to time, subject to the modifications specified in the following Rules.

Provided that with effect on and from the 15th September, 2016 the provisions contained in the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent posts in Branch-I-Medical of the Tamil Nadu Medical Subordinate Service shall apply to the holder of the post.

2. Constitution:-The following posts shall constitute a separate category in a distinct class in the said branch of the said service, namely:-.

- (1) Assistant Scientific Officer (Chemistry)
- (2) Assistant Scientific Officer (Microbiology)
- (3) Assistant Scientific Officer (Pharmacognosy)
- 3. Appointment:-Appointment to the posts shall be made as follows:-
 - (i) By recruitment by transfer from any other service, class or category; or
 - (ii) By direct recruitment, If no qualified and suitable candidates are available for appointment to the post by the above method.

4. Appointing Authority:-The appointing authority for the posts shall be the Director/Commissioner of Indian Medicine and Homeopathy, Chennai.

5. Qualifications:- (a) Age:- No person shall be eligible for appointment to the posts by direct recruitment, if he has completed or will complete the age of 35 years of age on the first day of July of the year in which the selection for appointment is made.

(b) Other Qualification:- No person shall be eligible for appointment to the posts specified in column (1) of the Table below, unless he possesses the following qualifications specified in column (3) thereof namely:-

6. **Reservation of Appointment:-** The Rule relating to Reservation of appointments (General Rule 22 for Tamil Nadu State and Subordinate Services) shall apply for appointment to the posts by direct recruitment:

Provided that with effect on and from 15th September 2016, the provisions contained in Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) shall apply for appointment to the post by direct recruitment.

7. **Probation:-** Every person appointed to the posts by direct recruitment shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years:

Provided that for the persons appointed to the posts by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.

8. Tests:- (a) Every person appointed, to the posts by direct recruitment shall, pass the Account test for Executive Officer within the period of his probation. Failing which his increment shall be stopped without cumulative effect, till he passes the said test.

(b) Every person appointed to the post by direct recruitment, shall also pass the Departmental Test in Tamil Nadu Medical Code within a period of three years from the date of his appointment to the said post, failing which his increment shall be stopped without cumulative effect, till he passes the said Test.

9. Pay:- There shall be paid to the holders of the posts a monthly pay in Level 12 of pay in the pay matrix of Rs.35600-112800.
