ORDER: No. 1764, Public (Protocol-III), 25th June 2020.

In the G.O. first read above, Major Ajay PS Rathore (IC-75630) from Indian Army was appointed as Aide-de-Camp (Army) to Hon'ble Governor of Tamil Nadu on deputation basis for a period of two years with effect from 09-02-2018 FN on the terms and conditions of the services intimated by Indian Army, New Delhi and his tenure expired on 08-02-2020. In the G.O. second read above, sanction was accorded for extension of the deputation tenure of Major Ajay PS Rathore from Indian Army as Aide-de-Camp to Hon'ble Governor of Tamil Nadu for a further period of four months with effect from 09-02-2020 with the same terms and conditions issued in the G.O. first read above.

2. Now, the Ministry of Defence, Government of India, New Delhi has stated that the Competent Authority has approved the extension of tenure of IC - 75630N Major Ajay PS Rathore, Aide-de-Camp to Governor of Tamil Nadu for two months beyond 09-06-2020 and has requested to issue necessary orders immediately under intimatiion to DMA. In the letter third read above, the Secretary to Governor, Raj Bhavan, Chennai, has therefore requested to issue necessary orders for extending the tenure of Major Ajay PS Rathore, Aide-de-Camp to Hon'ble Governor of Tamil Nadu for two months beyond 09-06-2020.

3. The Government hereby accord sanction for extension of the deputation tenure of Major Ajay PS Rathore (IC-75630N) from Indian Army as Aide-de-Camp to Hon'ble Governor of Tamil Nadu for a further period of two months with effect from 09-06-2020 under the existing terms and conditions issued *vide* G.O.Ms.No.370, Public (Protocol-III) Department, dated 24-05-2018.
