In exercise of the powers conferred under sub section(1) of Section 33 of Town and Country Planning Act 1971. (Act No. 35 of 1972) The Commissioner / Director of Town and Country Planning in the Proceedings ROC No. 4646/2020TCP2 dated. -07-2020 proposes to make the following individual draft variation for conversion of Residential use into Public and Semipublic use (Hospital) in ward No. 6 Block No. 92, T.S. No. 2851/33 (New T.S. No. 44) having an Extent of 1.28 Acres to the Approved Tiruchi-Nagapattinam bye pass road to the Detailed Development Plan No. 1 Thanjavur Local Planning Area Special Commissioner of Town and Country Planning's Proceedings Roc. Constitution of District Munsif-cum-Judicial Magistrate Court at Peravurani in Thanjavur District.

[Roc.No.1347/A/2014/G/Judn (Phase-II)]

No.VI(1)/269/2020.—

In exercise of the powers conferred by Section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) the High Court, Madras, hereby fixes peravurani in Thanjavur District as the place at which the District Munsif-cum-Judicial Magistrate Court, Peravurani, shall be located.

NOTIFICATION-II

No.VI(1)/270/2020.—

In exercise of the powers conferred by Section 11 of the Tamil Nadu Civil courts Act, 1873 (Central Act III of 1873) the High Court, Madras, hereby directs that in Thanjavur District, the District Munsif Court, Pattukottai, shall cease to have local jurisdiction over the entire Peravurani Taluk and the District Munsif-cum-Judicial Magistrate Court, Peravurani shall have and exercise local jurisdiction over the entire Taluk of Peravurani with effect from the date on which the District Munsif-cum-Judicial Magistrate, Peravurani assumes charge of that Court.

The High Court, Madras hereby directs and notifies that the District Munsif-cum-Judicial Magistrate, Peravurani in Thanjavur District shall exercise all the powers conferred on a District Munsif under Section 12 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) as amended up-to-date in regard to original suits and proceedings not otherwise exempted from his cognizance of which the amount or value of the subject matter does not exceed One Lakh rupees within the local limits of his jurisdiction with effect from the date on which the District Munsif-cum-Judicial Magistrate, Peravurani assumes charge of that Court.

In exercise of the powers conferred by Section 28 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) the High Court, Madras, hereby directs that the District Munsif-cum-Judicial Magistrate, Peravurani, shall have and exercise jurisdiction of a Court of Small causes under the Provincial Small Cause Act, 1887 for the trial of suits cognizable by a Court of Small Causes upto the pecuniary limits of Rs. 5000/- (Rupees five thousand only) with effect from the date on which the District Munsif-cum-Judicial Magistrate Court, Peravurani, Assumes charge of the Court.
