The Government of India has approved the "Pradhan Mantri" Matsya Sampada Yojana–A scheme to bring about Blue Revolution through sustainable and responsible development of fisheries sector in India" at a total investment of Rs.20,050 crore for its implementation for a period of 5 (five) years from FY 2020-21 to FY 2024-25 in all the States and Union Territories (UTs) for smooth implementation of Pradhan Mantri Matsya Sampada Yojana.

- 2. The Government of India has also requested to constitute a State Level Approval and Monitoring Committee in each State and District Level Committee at the District Level for smooth implementation of the Pradhan Mantri Matsya Sampada Yojana (PMMSY) including its supervision and monitoring.
- 3. The Director of Fisheries has sent the proposal to constitute State Level Approval and Monitoring Committee & District Level Committee and requested the Government to issue necessary notification for constitution of State Level Approval and Monitoring Committee and District Level Committee with Terms of References for the

smooth implementation, supervision and monitoring of projects sanctioned under Pradhan Mantri Matsya Sampada Yojana (PMMSY) in the State.

- 4. The Government after careful examination of the proposal of the Director of Fisheries and as per the Guidelines issued by the Government of India have decided to accept it. - (b) The State Level Approval and Monitoring Committee would be assisted by the State Programme Unit (SPU) for Pradhan Mantri Matsya Sampada Yojana.
- (c) The State Level Approval and Monitoring Committee shall undertake convergence of activities under Pradhan Mantri Matsya Sampada Yojana with activities/ interventions other Schemes and programmes at the State level.

- 3. On 03-08-2019 at 12.55 hours Fireman Sh. S.Mohan Sekar of Thiruchengode Fire and Rescue Services station was performing standby duty around the Cauvery River. He saw two persons swept away due to high current in Cauvery River and struggling in the river to save their

live near Patlur Parisalthurai, Eraiyamangalam, Namakkal District, Tamil Nadu. He immediately informed the Station Officer Sh. P.Sivakumar and without caring to risk to his life, jumped into the river which had 150 metre depth with water current around 1500 cubic feet per second He swam 200 metres in the river in order to save the boy and his father. Fireman C.Durairaj, Leading Fireman Sh. A.Govindasamy and Fireman Driver Sh. Satishkumar under the command and control of Station Officer Sh.Sivakumar Pandiyarajan reached at the spot and they also jumped into the river without caring to risk to their lives to help Fireman Sh.S.Mohan in the rescue operation. After a long struggle in the high current they rescued the boy and father in unconscious condition. Immediately the crew performed Cardiopulmonary Resuscitiation and Seved their lives.

- 4. Station Officer Sh. Sivakumar Pandiyarajan, Fireman Sh. Mohan Sekar, Leading Fireman Sh. Govindasamy Appavu, Fireman Driver Sh.
