Notice under Section 15 (1) of Tamil Nadu Highways Act, 2001 (TN Act 34 of 2002), read with the Tamil Nadu Land Acquisition Laws (Revival of Operation Amendment and Validation) Act, 2019.

The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below are to be acquired for the public purpose, that is, for the construction of Western Ring-Road to Coimbatore City, in **Madampatti Village of Perur Taluk, in Coimbatore District**, and it has already been decided that the entire amount of compensation to be awarded for the lands, is to be paid out of the funds controlled and managed by the Chief Engineer, Highways (Construction and Maintenance), Chennai and after having considered the cause shown by the owners or the other persons having interest on the said lands, as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).
