

"In exercise of the powers conferred under the first proviso to Section 13 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the High Court, Madras hereby directs that appeals from the decrees or orders of the District Munsif's Court at Nanguneri be preferred in the Court of Subordinate Judge at Nanguneri with effect from the date on which the Subordinate Judge assumes charge of Subordinate Judge's Court at Nanguneri."
