NOTIFICATIONS BY GOVERNMENT

HIGHWAYS AND MINOR PORTS DEPARTMENT

Amendments to the Special Rules for the Tamil Nadu Highways Engineering Subordinate Service.

[G.O.Ms. No. 122, Highways and Minor Ports (HM1), 3rd October 2020, புரட்டாசி 17, சார்வரி, திருவள்ளுவர் ஆண்டு–2051/

No. SRO B-33/2020.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Highways Engineering Subordinate Service (Section 15 in Volume III of the Tamil Nadu Services Manual, 2016).

AMENDMENTS.

In the said Special Rules,-

- 1. in rule 3, in the TABLE, for entry "(2) Promotion from the posts of Road Inspectors and Field Assistants who possess the Diploma/Licentiate in Civil engineering or Diploma/licentiate in Mechanical Engineering qualification and have rendered service for a period of not less than five years in the category they serve:" in column(2), against the entry "Junior Draughting Officers" in category 4 in column(1) thereof, the following entry shall be substituted, namely:-
- "(2) Promotion from the posts of Road Inspectors and Field Assistants who possess a Diploma in Civil Engineering and have rendered service for a period of not less than two years in the category they serve:";
 - 2. in Schedule II (referred to in rule 8), in the Tabular column(s),-
- (a) in column (1), for the entries "3 and 4. Head Draughting Officers in the office of the Chief Engineer (Highways), Civil Draughtsmen in the office of the Chief Engineer (General), Highways and elsewhere, Senior Draughting Officers, Draughting Officers and Junior Draughting Officers", the following entries shall be substituted, namely:-
- "3 and 4. Head Draughting Officers, Civil Draughtsmen, Senior Draughting Officers, Draughting Officers and Junior Draughting Officers.";
- (b) in column (2), against the entries "3 and 4. Head Draughting Officers, Civil Draughtsmen, Senior Draughting Officers, Draughting Officers and Junior Draughting Officers" as so substituted in column (1) thereof,-
 - (i) the following items shall be omitted, namely:-
- "(ii) A pass in sections A and B (Civil) of the Associate Member of Institution of Engineers (India) Examinations; or
- (iii) A pass in the Trade Test for Draughtsmen (Civil) conducted by the Director General of Resettlement and Employment and by the National Council for Vocational Training, Government of India:"
 - (ii) for item (iv), the following item shall be substituted namely:-
- "(ii) The qualifications specified below shall be necessary for appointment to the post of Junior Draughting Officer, by promotion or by recruitment by transfer, namely:-
- (a) Members of Category 5 (Assistant Draughtsman) who have acquired the qualification of a Diploma in Civil Engineering subsequently shall have a service of not less than two years in that category after acquiring such qualification; and
- (b) Members of Road Inspectors and Field Assistants who have acquired the qualification of a Diploma in Civil Engineering subsequently shall have a service of not less than two years in that category after acquiring such qualification:

Provided that while making appointment by direct recruitment to the post of Junior Draughting Officer, preference shall be given if other things being equal, to those who have undergone one year of apprenticeship training under the Government of India Scheme or the State Government Apprenticeship Scheme."

PERSONNEL AND ADMINISTRATIVE REFORMS DEPARTMENT

Amendment to the Fundamental Rules.

[G.O. Ms. No. 111, Personnel and Administrative Reforms (FR.II), 1st October 2020, புரட்டாசி 15, சார்வரி, திருவள்ளுவர் ஆண்டு–2051.]

No. SRO B-34/2020.—In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to the Fundamental Rules and the Instructions thereunder.

2. Amendment hereby made shall be deemed to have come into force on the 23rd day of March 2020.

AMENDMENT.

In the said Fundamental Rules, in Annexure-VII, under the Executive Instructions regarding Casual Leave under ruling (3) under rule 85, under the heading "II. Special Casual Leave", after rule 14, the following rule shall be added, namely:-

"15. Special Casual Leave for six days in a calendar year shall be granted to Government Servants having children with special needs on production of a supportive document obtained either from the authority competent to issue the certificate of disability under the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) or from a Registered Medical Practitioner attending to the child, certifying that he/she is a special child suffering from disability that requires parental support for daily life activities."

Amendments to the Special Rules for Tamil Nadu Basic Service.

[G.O. Ms. No. 113, Personnel and Administrative Reforms (F), 1st October 2020, புரட்டாசி 15, சார்வரி, திருவள்ளுவர் ஆண்டு–2051.]

No. SRO B-35/2020.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for Tamil Nadu Basic Service (Section 19 in Volume III of the Tamil Nadu Services Manual, 2016).

- 2. (i) The amendments (1) and (4) hereby made shall be deemed to have come into force on the 20th October 1993.
 - (ii) The amendment (2) hereby made shall be deemed to have come into force on the 3rd May 2002.
 - (iii) The amendment (3) hereby made shall be deemed to have come into force on the 15th September 2007.

AMENDMENTS

In the said Special Rules, in rule 5, in sub-rule (1), -

(1) after the first proviso, the following proviso shall be inserted, namely :-

"Provided further that the candidates belonging to Most Backward Classes and Denotified Communities, who do not possess a qualification higher than the Minimum General Educational Qualification, shall be eligible for appointment to the above classes, if he has not completed 32 years of age on the date of appointment:";

- (2) in the second proviso as so inserted, for the expression "Most Backward Classes", the expression "Backward Classes, Most Backward Classes" shall be substituted;
- (3) in the second proviso as so amended, for the expression "Backward Classes, Most Backward Classes", the expression "Backward Classes, Backward Class Muslims, Most Backward Classes" shall be substituted;
 - (4) in the third proviso, for the word "further", the word "also" shall be substituted.
