### Amendments to the Tamil Nadu Contract Labour (Regulation and Abolition) Rules, 1975.

[G.O. Ms. No. 181, Labour and Employment (H1), 10th November 2020, ஜப்பசி 25, சார்வரி, திருவள்ளுவர் ஆண்டு-2051.]

No.SRO A-41/2020.—In exercise of the powers conferred by Section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Contract Labour (Regulation and Abolition) Rules,1975, the draft of the same having been previously published, as required under sub-section (1) of Section 35 of the said Act.

#### AMENDMENTS

In the said Rules,-

- (1) after rule 80, the following rule shall be inserted, namely:-
- **"80A.** Notwithstanding anything contained in these rules, the registers and records required to be maintained by principal employer / contractor shall also be maintained in Electronic Form,",
- (2) in rule 82, in the proviso to sub-rule (2), after the expression, "Tamil Nadu Factories Rules, 1950", the expression, "or Combined Annual Return in Form XXV under Schedule XIII as required in rule 242 of the Tamil Nadu Building and other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2006" shall be inserted.

#### Amendments to the Tamil Nadu Legislators' (Medical Attendance and Treatment to former Members) Rules, 1982.

No.SRO A-42/2020.—In exercise of the powers conferred by Section 14 *read* with sub-section (4) of Section 12 of the Tamil Nadu Payment of Salaries Act, 1951 (Tamil Nadu Act XX of 1951), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Legislators' (Medical Attendance and Treatment to former Members) Rules, 1982.

2. The amendments hereby made shall be deemed to have come into force on the 1st April 2020.

#### AMENDMENTS.

In the said Rules. -

- (1) in rule 3, in the first proviso, for the expression "Rs.30,000/- (Rupees Thirty thousand only)", the expression "Rs.50,000/- (Rupees Fifty thousand only)" shall be substituted;
- (2) in the APPENDIX, in Certificate under Form 'C', for the expression "Rs.30,000/- (Rupees Thirty thousand only)", the expression "Rs.50,000/-(Rupees Fifty thousand only)" shall be substituted.
