Notice is hereby given that the Principal District and Sessions Court, Sivagangai and other Subordinate Civil Courts in Sivagangai District will be closed for Summer Vacation for the year 2020 as detailed below.

SUMMER VACATION – 2020

1. The Principal District and Sessions Court of Sivagangai, The Additional District and Sessions Court, Sivagangai and the Civil Courts of the Subordinate and Assistant Sessions Judges of Sivagangai, Manamadurai and Devakottai will remain closed from Friday, the 1st day of May-2020 to Sunday, the 31st day of May -2020. (both days inclusive).

The District Munsif of Sivagangai, Devakottai, the Court of Principal District Munsif, Manamadurai, the Court of Additional District Munsif, Karaikudi, the Courts of District Munsif *cum* Judicial Magistrates, Karaikudi, Thiruppathur and Ilayangudi, Thiruppuvanam, Singampunari (Civil side) and the Court of Additional District Munsif *cum* Judicial Magistrate, Manamadurai (Civil Side) will remain closed from Friday, the 1st day of May-2020 to Sunday, the 31st day of May -2020 (both days inclusive).

7. The Office of the other departments will remain closed. Arrangements will however be made

(a) for transmitting records in appeals etc., to the Honourable High Court;

(b) for attending the all administrative correspondences;

(c) for furnishing the copies and process service with necessary records and Original Orders; and

(d) for receiving the printing charges and plan fees etc., deposited into Court in respect of Copy application.

8. Urgent applications for bail during the absence of the Sessions Judge from the Sivagangai Division during the Vacation should be made to the Honourable Madurai Bench of Madras High Court, Madurai provided no Vacation Sessions Judge is appointed for Sivagangai Division.
