## Amendments to the Special Rules for the Tamil Nadu Elementary Educational Subordinate Service.

[G.O. Ms. No.204, School Education (EE1(1)), 15th November 2019, Aippasi 29, Vikari, Thiruvalluvar Aandu-2050.]

No. SRO B-5/2020.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Elementary Educational Subordinate Service (Section 48A in volume-III of the Tamil Nadu Services Manual, 2016):-

- 2. The amendments hereby made shall be deemed to have come into force on the following dates:-
  - 1. Amendment 1 shall be deemed to have came into force on the 19th June 1989.
  - 2. Amendments 3 (iii) and 6(iii) shall be deemed to have come into force on the 27th June 1989.
  - 3. Amendments 3 (i) (b) and 6(i)(b)shall be deemed to have come into force on the 7th June 1999.
  - 4. Amendments 2 (ii) (a), (b), 3 (ii) (a), (b) and 6 (ii) (a) and (b) shall be deemed to have come into force on the 27th June 2003.
  - 5. Amendments 3 (i) (c) and (ii) (c) shall be deemed to have come into force on the 22nd September, 2007.
  - 6. Amendment 6 (i) (a) shall be deemed to have come into force on the 25th July 2007.
  - 7. Amendments 2 (i), (ii) (c), 3 (i) (d), (ii) (d), 4 (i), 6(i) (c) and 6 (ii) (c) shall be deemed to have come into force on the 25th July 2008.
  - 8. Amendment 6 (ii) (d) shall be deemed to have come into force on the 15th November, 2011.

- (iii) If no qualified and suitable candidate is available for appointment by any of the methods specified in item (i) and (ii) above, then by direct recruitment.

No. SRO B-6/2020.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India,, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Higher Secondary Educational Service. (Section 37 in Volume-II of the Tamil Nadu Services Manual 2016).

The amendments hereby made shall be deemed to have come into force on the following dates:-

- 1. The Amendment 2(i)(a) shall be deemed to have come into force on the 25th August 2008.
- 2. The Amendment 1, 2(ii), 4 and 5 shall be deemed to have come into force on the 10th July 2009.

- (c) After the item "(iii)" in column (3), against the category 2 Post Graduate Assistants in Languages" in column(2), the following item shall be added, namely:-
  - "(iv) (a) Recruitment by transfer from the post of Superintendent in the Tamil Nadu Ministerial Service in School Education Department;
    - (b) If no qualified and suitable candidates are available for appointment by the method (a) above, recruitment by transfer from the posts of Assistant/ Steno-Typist in the Tamil Nadu Ministerial Service in School Education Department;
    - (c) If no qualified and suitable candidates are available for appointment by the method (a) and (b) above, recruitment by transfer from the posts of Junior Assistant/ Typist in the Tamil Nadu Ministerial Service in School Education Department;"
- (ii) in class III,-
  - (a) the categories 1 and 2 in column (2) shall be renumbered as categories "2" and "3"
  - (b) before the category as so renumbered the following category and entries in column (2) and (3) shall, respectively, be inserted, namely:-

"1 District Inspectors of Physical Education"

By transfer from category 2 of Class III";

- (ii) in sub-rule (b), for the expression "clause (14) of rule 2 in Part I of the Tamil Nadu State and Subordinate Services rules" the expression "clause (r) in Section 3 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016" shall be substituted.
- (3) in rule 6,- for the expression "The rule of reservation of appointment (General rule 22)" the expression "The principle of reservation of appointments [Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016]" shall be substituted.
  - (4) in rule 7,-
    - (i) in sub-rule (a),- for the expression "General rule 21" the expression "Section 26 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016," shall be substituted;
    - (ii) in sub-rule (c),- for the expression "under the proviso to General rule 21" the expression "under the proviso to Section 26 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016," shall be substituted;
  - (5) in rule 9,- after the proviso to sub-rule (c), the following proviso shall be added, namely:-
    - "Provided further that, the Pandits and Munshis other than Tamil who relinquish their right of promotion to administrative posts are exempted from passing the Language Test";
  - (6) in rule 11, for the expression "under the rule 10 (a) (i) of the General rules for the Tamil Nadu State and Subordinate Services the expression "Section 17(1) of the Tamil Nadu Government Servants (conditions of service) Act, 2016," shall be substituted;
  - (7) for rule 14,- the following shall be substituted, namely:-
    - "(14) Seniority.- The seniority of teachers transferred to one unit from another unit shall be reckoned with reference to the date of joining to the category in which he was transferred subject to the following condition:-

An approved probationer in the post appointed in the other units will be placed below the approved probationers in identical category in this unit.";

- (8) in the Annexure II referred to in rule 9,-
  - (i) the entries in column (3) against the category "Deputy Inspectors of School and Graduate Teachers" in column (1), and the method of Appointment "Direct recruitment" in column (2) shall be numbered as (i);
  - (ii) after the entries and proviso as so numbered the following entries shall be added, namely:-
    - "(ii) Pass in Teachers Eligibility Test (TET);"
  - (iii) (a) for the expression "Pandits and Munshis (other than those in Hindi), Grade I including" in column (1), the expression "School Assistants (other than those in Hindi) including" shall be substituted;
  - (b) for the expression "School Assistants (other than those in Hindi) including" in column (1) the expression "Graduate Teacher (other than those in Hindi) including" shall be substituted;
  - (iv) after the entries in item (ii) in column (3) against the category "Graduate Teacher (other than those in Hindi) including Graduate Teacher in Tamil" in column (1), the following entries shall be added, namely:-
    - "(iii) Pass in Teachers Eligibility Test (TET).";
  - (v) (a) the existing entry in column (3) against the category "Secondary Grade Teacher" in column (1), shall be numbered as "(i)";
    - (b) after the entry as so numbered the following entry shall be added, namely:-
      - "(ii) Pass in Teachers Eligibility Test (TET).";
