Order: No.52, Housing and Urban Development, 23rd February 2021.

The Hon'ble Deputy Chief Minister on the floor of the Assembly (2020-2021) during the Demand for Housing and Urban Development Department on 24-03-2020 has announced as follows:-

"சென்னை பெருங்களத்தூரில் 28.20 ஏக்கர் பரப்பளவில் மனைப்பிரிவு திட்டம் ஏற்படுத்துதல்"

- 2. In the Government Order first read above, orders have been issued, among other things, that in future, the Co-operative Housing Society should undertake consignment Scheme only with the prior approval of the Government.
- 3. The Registrar of Co-operative Societies (Housing) in his Letter Second read above has stated that, the South Chennai Co-operative Housing Society has submitted a house Site Scheme at Nedunkundram Village, Chengalpet Taluk, Kancheepuram District on Consignment basis at an extent of 28.20 acres and furnished the following in this regard:-
- I. The CMDA has accorded Sanction for Layout *vide* Letter no L1/14228/2019, dated 13/03/2020. The proposed Layout has 716 Number of plots including 219 plots meant for Economically Weaker Sections (EWS) and 2 shop sites.
- II. The Additional Government Pleader of Madras High Court, in his legal opinion, has stated that Thiru.J.Vijay Surana is the Power holder of the whole land for these properties.

- III. The copies of documents, Government Pleader opinion about the marketable title to the property, Encumbrance Certificate as mentioned in the Government Pleader Opinion, Copy of the CMDA approved plan along with proceedings therein and the copy of the Gift Deed for having handed over the Road portion and park areas earmarked in the approved layout to the local body.
- IV. The Board of Management of the society in its meeting held on 30-12-2019 *vide* Resolution No.1 has resolved to request the Government through Registrar of Co-operative Societies (Housing) to accord necessary permission to implement the scheme with stamp duty exemption.
- 4. The Registrar of Co-operative Societies (Housing) has further informed that as per G.O.Ms.No.2179, Agriculture (Co-operation) Department, dated 29-06-1966, the Co-operative Societies are exempted from payment of Stamp Duty.
- 5. The Registrar of Co-operative Societies(Housing), has therefore, requested the Government to accord permission to process and implement the house site scheme Nedunkundram Village, Chengalpet Taluk, at Kancheepuram District on Consignment basis at an extent of 28.20 acres with reference to the existing guideline for the implementation of the layout "under consignment scheme" with certain conditions.
- 6. The Government after careful consideration, accept the proposal of the Registrar of co-operative Societies (Housing) and accord approval, as a special case, to implement the consignment scheme at Nedunkundram Village, Chengalpet Taluk, Kancheepuram District through the South Chennai Co-operative Housing Society as per G.O.D.No.16, Housing and Urban Development Department, dated 11-01-2010 with stamp duty exemption under consignment basis subject to the condition that no more such exemption shall be considered as routine course and with the following conditions:-
- a. The scheme should be implemented on consignment basis.
- b. The society should get the approval in the next general body for the implementation of the scheme.
- c. Purchase price and Selling price on consignment basis of the proposed site are to be fixed by a "Pricing Committee" consisting of Regional Deputy Registrar (Housing) Chennai as Chairman, President of the society, Secretary of the Society, Supervisor/Co-operative Sub-Registrar and Co-operative Sub-Registrar of the O/o. the Deputy Registrar (Housing) Chennai Region as members.

- d. The society shall advertise in the leading dailies approved by the Director of information and Public Information for assessing the demand of the scheme.
- e. The Society should complete booking/ Purchasing the plots from the landowner within 15 months. However this scheme should be completed within 18 months in total. If the scheme could not be completed within the stipulated time and if required necessary proposal should be submitted well in advance seeking permission from the Government for the continuance of the scheme. Unsold plots in this scheme should be returned to the land owner.
- f. Up to date Encumbrance Certificate should be obtained and ascertained that there is no pending encumbrance.
- g. This scheme shall be executed only with the advance/payments received from the members. Society funds should not be utilized, under any circumstances.
- 7. This order issues with the concurrence of Finance Department *vide* its U.O.No.9688/Fin(Hg&UD)/2021, dated 22-02-2021.
