Establishment - Museums - Sanctioning of certain posts in the Newly established Museum at Ariyalur District.—Orders Issued.

In the G.O. first *read* above, orders were issued sanctioning a sum of Rs.2 crore for the establishment of a Fossil Museum at Varanavasi, Keelapaluvur, Ariyalur District as detailed below:-

- 2. In the G.O. second *read* above, an amendment was issued adding few lines so as to execute the remittance work through the Public Works Department, adopting the existing rules and procedures.
- 3. In the letter third read above, the Director of Museums has stated that the land selected in Varanavasi, Keelapaluvur Area, Ariyalur District has been transferred to the Museum Department for the establishment of Fossil Museum. The building works have been completed by the Public Works Department. Geologically this area is unique, because fossils found here are 65 million years old. A small area of cretaceous era has been preserved here, converted as Museum with adequate labels to transfer the knowledge to posterity and Geological specimens like Minerals Fossils (Botanical, Zoological) and rocks (Igneous, sand and meta-morphic rocks) are to be displayed here. The posts of Curator, Assistant Curator/Guide, Junior Assistant, Technical Assistant, Four Gallery Guards, two night watchmen and driver are very essential and created for the functioning of this Fossil Museum at Ariyalur District and the annual expenditure for the creation of the above posts is Rs. 29,02,620/-. He has therefore requested to sanction the above posts for the immediate functioning of Fossil Museum at Varanavasi, Keelapaluvur Area, Ariyalur District.
- 4. The Government after careful examination have decided to accept the proposal of the Commissioner of Museums and sanction the following posts by relaxing G.O.(Ms) No. 248, Finance (CMPC) Department, Dated 20-03-2020 and sanction a sum of Rs. 29,02,620/(Rupees Twenty Nine lakhs two thousands six hundred and twenty only) for the immediate functioning of the Newly established Museum at Ariyalur District:-

- i One post of Curator and One post of Technical Assistant shall be covered under Tamil Nadu General Subordinate service, while filling up the said posts, relevant rules / Act / orders / instructions in vogue should be strictly followed as per Tamil Nadu Government Servant (Conditions of Service) Act, 2016.
- ii. One post of Assistant Curator / Guide and One post of Junior Assistant shall be covered under Tamil Nadu General Sub-ordinate service rule and State Scale of pay, While filling up the said posts, proper recruitment procedure should be strictly followed as per Tamil Nadu Government Servant (Conditions of Service) Act, 2016.

- iii. Four posts of Gallery Guard, two posts of watchmen and one post of Driver shall be filled up through Annamalai University Staff.
- 5. The amount sanctioned in para 4 above shall be debited the following head of account.
