#### Amendments to the Special Rules for The Tamil Nadu Public Health Service

[G.O.Ms.No. 205, Health and Family Welfare (L2), 19th April 2021, Chithirai 6, Pilava, Thiruvalluvar Aandu–2052.]

No. SRO B-22/2021.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Public Health Service (Section 24 in Volume II of the Tamil Nadu Services Manual, 2016.)

2. The amendments hereby made shall be deemed to have come into force on and from 22nd October, 2018.

#### **AMENDMENTS**

In the said Special Rules,-

- (1) In rule-1, under the heading "Class I", for Category 6, the following Categories shall be inserted, namely:-
  - "6. Chief Entomologist
  - 6A. Regional Entomologist.";
- (2) in rule 2, in the tabular column under the heading "Class I",-
  - (i) for Category 6 in column (1) and the corresponding entries in column (2) thereof, the following Categories and the entries relating thereto, shall, respectively, be substituted, namely:-

"6. Chief Entomologist By promotion from among the holder of

the post of Regional Entomologist;

6A. Regional Entomologist By promotion from among the holder of

the post of Senior Entomologist / District Malaria Officer / District Entomologist / Lecturer in Medical Entomology /

Entomologist / Biologist.",

- (3) in rule 4, in sub-rule (1), in the TABLE, under the heading "Class I",-
  - (i) for Category 6 in column (1) and the corresponding entries in columns (2) and (3) thereof, the following Categories and entries shall, respectively, be substituted, namely:-

"6. Chief Promotion from Entomologist Category 6A.

Must possess M.Sc. degree in Zoology of an University or Institution recognised by the university Grants Commission for the purpose of its grant or an equivalent qualification in Entomology; and

(ii) Must have put in an approved Service of not less than three years as Regional Entomologist. 6A. Regional Entomologist Promotion from Category 7.

- (i) Must possess M.Sc. degree in Zoology of an University or Institution recognised by the University Grants Commission for the purpose of grant or an equivalent qualification in Entomology; and
- (ii) Must have put in an approved Service of not less than five years as Senior Entomologist / District Malaria Officer / District Entomologist / Lecturer in Medical Entomology / Entomologist / Biologist.
- (4) for rule 9, the following rule shall be substituted, namely:-
  - "9. Appointing authority;- (1) The appointing authority in respect of Statistical Officer, Assistant Director (State Bureau of Health Intelligence), Medical Officer (Maternal and Child Health), Regional Entomologist and Senior Entomologist / District Malaria Officer / District Entomologist / Lecturer in Medical Entomology / Entomologist / Biologist and Lecturer in Medical Entomology in the Medical College shall be the Director of Public Health and Preventive Medicine.
- (2) The appointing authority in respect of Chief Entomologist shall be the Government."
