#### Amendment to the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Rules, 1986.

No.SRO A-12/2021.— In exercise of the powers conferred by sub-section (1) of Section 32 of the Tamil Nadu Manual Workers (Regulation of Employment and Canditions of Work) Act, 1982 (Tamil Nadu Act 33 of 1982), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Manual Workers (Regulation of Employment and Conditions of Work) Rules, 1986 namely:-

AMENDMENTS.

In the said Rules,-

(1) in rule 3 in clause (b),-

(a) for the expression "Joint Commissioner of Labour", the expression "Additional Commissioner of Labour", shall be substituted;

(b) for the expression "Deputy Commissioner of Labour", the expression "Joint Commissioner of Labour", shall be substituted;

(2) in rule 18,-

(a) in sub-rule (1), for the expression "Deputy Commissioner of Labour", the expression "Joint Commissioner of Labour", shall be substituted;

(b) in sub-rule (2), for the expression "Labour Officer or Inspector of Plantation" the expression "Assistant Commissioner of Labour or Assistant Commissioner of Labour (Plantation)", shall be substituted.
