No. SRO B-2/2021.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for Tamil Nadu Agricultural Extension Subordinate Service (Section-I in Volume III of the Tamil Nadu Service Manual, 1970.)

- 2) The amendment hereby made shall be deemed to have come into force on and from 15th September, 2016.

#### AMENDMENT

In the said Special Rules, for rule 6, the following rule shall be substituted, namely:-

**"Reservation of appointments:-** The Provisions contained in **Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016)** shall apply for appointment to the post of Assistant Agricultural Officer by direct recruitment".
