In exercise of the powers conferred by sub-rule (1) of rule 9 of the Indian Police Service (Recruitment) Rules, 1954, read with sub-regulation (1) of regulation 9 of the Indian Police Service (Appointment by Promotion) Regulations, 1955, the President is pleased to re-appoint Smt. S. Mallikha (D.O.B 14.03.1969) and Shri Pa. Moorthy (D.O.B 05.05.1967)

(Officers earlier appointed from Select Lists 2010 & 2014) to the Indian Police Service of Tamil Nadu Cadre against the Select Lists of 2008 & 2013 with all consequential benefits.
