The Governor of Tamil Nadu further appoints the following 3 (three) Candidates, who have been provisionally and Conditionally selected to act temporarily as Civil Judge (Junior Division) in the Tamil Nadu State Judicial Service for the years 2018-2020, subject to the condition that they are to be referred to the DVC/SLSC for verification and the Community claim shall be accepted based on the report to be received from the DVC/SLSC along with the records of enquiry. After acceptance of his/her community claim, by the DVC/SLSC, the fact should be informed to the Commission along with a copy of the verification report, so as to finalise their provisional and conditional selection. He/she is directed to appear before the DVC/SLSC when summoned and to co-operate in the enquiry with regard to their claim. Further, if the community claim of the above said candidates is found to be false, he/she is

liable for such penal and legal action including recovery of salary as a consequence thereof. Hence, his/her temporary services in the said post should not be regularized before the receipt and acceptance of the report on the genuineness of the community claim by the DVC/SLSC.
