- (ii) Under the heading "Dry Agricultural use zone" the following S.Nos.126 (excepted 126/12), 127 (excepted 127/1A, 127/1B, 127/2,) 128 and 129 shall be deleted and 130 (excepted 130/1), 131, 132 shall be substituted instead of 126 to 132.
