The Committee shall follow the guiding principles issued by Government of India, Ministry of Health and Family Welfare and Indian Council of Medical Research for Issue of Official Document of COVID-19 Death as detailed below:-

#### **Guiding Principles.**

- COVID-19 cases, for the purpose of these Guidelines, are those which are diagnosed through a positive RT-PCR/Molecular Tests/RAT <u>OR</u> clinically determined through investigations in a hospital/in-patient facility by a treating physician, while admitted in the hospital/ in-patient facility.
- ii. Deaths occurring due to poisoning, suicide, homicide, deaths due to accident etc. will not be considered as COVID-19 deaths even if COVID-19 is an accompanying condition.

#### Scenario based approach and interventions

- i. COVID-19 cases which are not resolved and have died either in hospital settings or at home, and where a Medical Certificate of Cause of Death (MCCD) in Form 4 & 4A has been issued to the registering authority, as required under Section 10 of the Registration of Birth and Death (RBD) Act, 1969, will be treated as a COVID-19 death. Registrar General of India (RGI) will issue necessary guidelines to Chief Registrars of all States/UTs.
- ii. As per the study by Indian Council of Medical Research (ICMR), 95% deaths take place within 25 days of being tested Covid positive. To make the scope broader and more inclusive, deaths occuring within 30 days from the date of testing or from the date of being clinically determined as a COVID-19 case, will be treated as 'deaths due to COVID-19', even if the death takes place outside the hospital/ in-patient facility.
- iii. However, a COVID-19 case, while admitted in the hospital/in-patient facility, and who continued as the same admission beyond 30 days, and died subsequently, shall be treated as a COVID-19 death.
- iv. In cases where the MCCD is not available or the next of kin of the deceased is not satisfied with the cause of death given in MCCD (Form 4/4A), and which are not covered by the aforesaid scenarios. The Committee shall issue Official Document for COVID-19 Death.

# Functions of the District Level Committee (Including Greater Chennai Corporation)

- The next of kin of the deceased shall submit a petition to the District Collector for issuance of the appropriate Official Document for COVID-19 Death.
  - The Committee is to scrutinize and examine all the petitions received from the next of the kin of the deceased through District Collector once in a week for issue of 'Official document for COVID-19 Death's to the concerned family members.
- The "Official Document for COVID-19 Death" will be issued by the District Level Committee in the specified format annexed after due examination and verification of all facts.

- iii. The official document for COVID-19 Death shall also be communicated to the Director of Public Health and Preventive Medicine and Chief Registrar of Births and Deaths and the Registrar of Birth and Death who issued the death certificate.
- iv. The Committee may interview the Stake holders to validate the information in the death related documents.
- v. The Committee shall also examine the grievances of the next of kin of the deceased, and propose necessary remedial measures, including issuance of amended Official Document for COVID-19 Death after verifying facts in accordance with the aforesaid guidelines issued by the Ministry of Health and Family Welfare.
- vi. The Committee would recommend appropriate measures to be taken up while certifying the cause of death in MCCD with regard to COVID-19 Deaths.
- vii. The application for issuance of Official Document for COVID-19 Death and for redressal of grievances shall be disposed off within 30 days of submission of the application/grievance.

The Registrar General, Hon'ble Court High of Madras, in his letters fourth and fifth read above, has stated that the Hon'ble Full Court by its resolution, dated 14-7-2015, have directed him to address the Government for issuing a fresh Government order to constitute a separate State Level Committee for southern Zone to deal with the complaint or information relating to the dispute between the Advocates (who are on the roll of the Tamil Nadu State Bar Council), practicing at the Madurai Bench of Madras High Court and in the districts coming within the Jurisdiction of the Madurai Bench and the Police Officials functioning in those places.

2. The Government examined the proposal of the Registrar-General, Hon'ble High Court of Madras and have dicided to accept it. Accordingly, the Government constitute a separate State Level Coordination Committee (Southern Zone) to deal with the complaint or information relating to the dispute between the Advocate (who are on the roll of the Tamil Nadu State Bar Council) practicing at the Madurai Bench of Madras High Court and in the Districts coming within the Jurisdiction of the Madurai Bench and the Police Officials functioning in those places with the following composition of High Level Officials:-

1	Two Hon'ble Judges of the Madurai Bench of Madras High Court, to be nominated by the Hon'ble Chief Justice. The Hon'ble Senior Judge shall be the Chairperson and the other Hon'ble Judge shall be the Member.	Chairperson/ Member

The Additional Registrar-General, Madurai Bench of Madras High Court, Madurai, shall Co-ordinate the meetings of the Committee and the Chairman of the Bar Council of Tamil Nadu shall assist him in convening the meetings and record the minutes of the meeting. The Committee, on its being constituted, shall receive the complaint or information relating to dispute between the Advocates (who are on the roll of the Tamil Nadu State Bar council) and the Police Officials functioning within the Jurisdiction of the Hon'ble Madurai Bench of Madras High Court, which are referred by the members of the respective Bar Association or by the State Bar Council or by the District Judges to the Additional Registrar-General, Madurai Bench of Madras High Court. Upon receipt of the complaint, the matter shall be placed before the Chairperson of the State Level Co-ordination Committee (Souther Zone) and on his orders, the meeting of the Committee shall be convened and appropriate directions be issued on the said complaint. The Committee shall adopt its own procedure in arriving at the conclusions and recommendations. The Members of the Bar Associations, including their federations and the Tamil Nadu State Bar Council are requested to approach the State Level Co-ordination Committee (Southern Zone) with a view to resolve any accusation made against the Police regarding their misbehavior towards the Members of the Bar Associations and abide by the decision of the Committee.

Late Rajkumar Rajenderan (Posthumous) Fireman

- 2. Late Rajkumar Rajenderan, Fireman, was working in Tamil Nadu Fire & Rescue Services during the year 2020.
- On 12-08-2020 around 17.27 hrs a rescue call received at Perambalur Fire & Rescue Station about the trapping of two persons in a well at Selliyampalayam, Perambalur Taluk, Perambalur District. On receipt of call, Station officer P. Sathiyavarthan along with his crew immediately rushed to the spot. On reaching the site, the crew found that two persons trapped in 65 feet well and were fighting for their lives. Analyzing the seriousness of the situation, the Fireman 8149 Sh. R. Rajkumar immediately came forward to descend to the well, without caring to the risk involved to his life. As on the trapped persons Baskaran was struggling to breath, the Fireman 8149 R. Rajkumar, put the rescue know and signaled the crew members to drag the rope by which the Baskar was rescued and admitted in the nearest hospital. While trying to rescue the second person, the Fireman 8149 Thiru R. Rajkumar fainted and fed down due to poisonous gas in the well. Immediately the crew member Thiru M. Balraj, Fireman 8840 and Thiru D. Dhanapal Fireman Driver 8601 rescued the Fireman 8149 Thiru R. Rajkumar and admitted in the hospital where he was declared dead.
- 4. Late Rajkumar Rajenderan Fireman, thus displayed conspicuous gallantry, exemplary courage, professional expertise and devotion to duty of a very high order.
