HEALTH AND FAMILY WELFARE DEPARTMENT

Amendment to the Special Rules for the Tamil Nadu Medical Subordinate Service

[G.O. Ms. No.385, Health and Family Welfare (C2), 27th August 2021, Aavani 11, Pilava, Thiruvalluvar Aandu-2052.]

No. SRO-B 50/2021.--In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Medical Subordinate Service (Section 21 in Volume - III of the Tamil Nadu Services Manual, 1970)

The amendment hereby made shall be deemed to have come into force on and from 26th February 2021.

AMENDMENT

In the said Special Rules, in Part II, under the heading Branch IV - General, in Annexure-II, under Class II, for the entries in Column (2) against the entry "Category - 4 Dark Room Assistants in Column (1), for the existing first proviso under heading "**By Direct Recruitment, or for Special reasons, by recruitment by transfer from any other Service**" thereof, the following proviso, shall be substituted, namely:-

Provided that if candidates with the certificate of Dark Room Assistant are not available, then candidates with Certificate of Radiological Assistant of any Institution recognized by the State Government or Government of India, with or without science in Higher Secondary Course, shall be appointed.

Special Rules for the Tamil Nadu Food Safety Service

[G.O. Ms. No.412, Health and Family Welfare (M1), 23rd September 2021, புரட்டாசி 7, பிலவ், திருவள்ளூர் ஆண்டு-2052.]

No. SRO-B 51/2021.--In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Special Rules for the Tamil Nadu Food Safety Service, which shall form part as Section 55 in Volume - II of the Tamil Nadu Services Manual, 2016:-

2. The rules hereby made shall be deemed to have come into force on and from the 18th February 2015.

RULES

1. Constitution:- The Service shall consist of the following posts, namely:-

- (1) Chief Food Analyst.
- (2) Food Analyst.
- (3) Deputy Food Analyst.
- (4) Senior Analyst.

2. Appointment.- Appointment to the posts specified in column (1) of the Table below shall be made by the methods specified in the corresponding entries in column (2) thereof:-

THE TABLE

Posts (1)	Method of Appointment (2)
(1) Chief Food Analyst	By promotion from among the holders of the post of Food Analyst
(2) Food Analyst	By promotion from among the holders by the post of Deputy Food Analyst; (or) By promotion from among the holders of the post of Senior Analyst, if no suitable and qualified persons are available in the post of Deputy Food Analyst; (or) By promotion from among the holders of the post of Microbiologist in the Tamil Nadu Food Safety Service; if no suitable and qualified persons are available in the above said two posts.

	<i>Posts (1)</i>	<i>Method of Appointment (2)</i>
(3)	Deputy Food Analyst	(i) By promotion from among the holders of the post of Senior Analyst; (or) (ii) By direct recruitment, if no suitable and qualified person is available by promotion.
(4)	Senior Analyst	(i) By recruitment by transfer from the post of Junior Analyst in the Tamil Nadu Food Safety Subordinate Service; or (ii) by direct recruitment, if no suitable and qualified person is available by recruitment by transfer.

3. Appointing Authority.- The appointing authority for the posts specified in column (1) of the Table below shall be the authorities specified in the corresponding entries in column (2) thereof:-

(1) Chief Food Analyst	Government
(2) Food Analyst	Government
(3) Deputy Food Analyst	Government
(4) Senior Analyst	Government

4. Qualifications - (a) Age- No person shall be eligible for appointment to the posts by Direct recruitment, if he has completed or will complete the age of thirty years on the first day of July of the year in which the vacancy is notified.

(b) Other Qualifications - No person shall be eligible for appointment to the posts specified in the column (1) of the Table below by the method specified in the corresponding entries in column (2) thereof, unless he possesses the qualifications specified in the corresponding entries in column (3) thereof:-

<i>Posts (1)</i>	<i>Methods of appointment (2)</i>	<i>Qualification (3)</i>
Deputy Food Analyst	By Direct recruitment.	A degree in Science with Chemistry or Bio-Chemistry or Food Technology or Food and Drugs with experience for a period of not less than five years in the Analysis of Food; or A Master's degree in Chemistry or Bio-Chemistry or Food Technology or Microbiology or Food and Drugs with experience for a period of not less than three years in the Analysis of Food.
Senior Analyst	By Direct recruitment.	A degree in Science with Chemistry or Bio-Chemistry or Food Technology or Food and Drugs with experience for a period of not less than four years in the Analysis of Food; (or) A Master's degree in Chemistry or Bio-Chemistry or Food Technology or Microbiology or Food and Drugs with experience for a period of not less than two years in the Analysis of Food.

5. Reservation of Appointment - The rule relating to reservation of appointment (General Rule 22) shall apply for appointment to the posts by direct recruitment:

Provided that with effect on and from the 15th September 2016, the provisions contained in Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) shall apply for appointment to the posts by direct recruitment.

6. Probation - Every person appointed to the post by direct recruitment shall, from the date on which he joins duty be on probation, for a total period of two years on duty within a continuous period of three years:

Provided that every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty be on probation for a total period of one year on duty within a continuous period of two years.

7. Preparation of annual list of approved candidates - For the purpose of preparation of the annual list of approved candidates for appointment to the posts either by promotion or by recruitment by transfer, the crucial date on which the candidate should have acquired the prescribed qualifications shall be the 15th February of every year.

8. Test - Every person appointed to the post by direct recruitment shall pass Account Test for Executive Officers within the period of probation.

If the person appointed to the above said post does not pass the above tests within the period of his probation, he shall not be allowed to draw his second and subsequent increments until he passes the tests. Such ineligibility to draw increments shall not have the effect of postponing his future increment after he passes the test.

9. Saving - Nothing contained in these rules shall adversely affect any person holding the posts as on the date of issue of these rules.

Amendments to the Adhoc Rules for the Tamil Nadu Educational Service

No. SRO-B 52/2021.- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules issued with the Higher Education Department Notification No.SRO B-39/2006 published at page 70 in Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 19th July 2006:-

2. The amendments hereby made shall be deemed to have come into force on the date of issue of orders.

AMENDMENTS

In the said Rules,

(1) in rule 4, in sub-rule (b), the following proviso shall be inserted, namely:-

"Provided also that for the purpose of appointment to the post of Lecturer in Garment Technology, the following qualification shall be considered namely:-

Bachelor's Degree(Engineering) in Textile Technology / Textile Chemistry / B.Des.(Design) in appropriate discipline with First class or its equivalent. If a candidate has a first class Master's Degree, or its equivalent is required at Bachelor's or Master's level in relevant discipline.

(OR)

First class Master of Science in Fashion Technology / Clothing / Garment Technology of a recognized University / Institution."

(2) after rule 8, the following rule shall be added, namely:-

"9. Savings Nothing contained in these rules shall adversely affect the persons holding the post on the date of publication of these rules in the *Tamil Nadu Government Gazette*". .

No. SRO-B 53/2021.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments, to the rules published with the Higher Education Department Notification No.SRO B 159/97 at pages 170 to 171 in Part III—Section 1 (b) of the *Tamil Nadu Government Gazzette* dated the 17th December. 1997.

2. The amendments hereby made shall be deemed to have come into force on 25 May, 2010.

AMENDMENTS

In the said Rules,

(1) in rule 4, in sub-rule (b), before the last proviso, the following proviso shall be added, namely:-

"Provided also that for the purpose of appointment to the post of Lecturer in Sugar Technology, the branch of Engineering shall be "B.E / B.Tech in Chemical Engineering". If the candidate has a Master's Degree in the appropriate branch of Engineering / Technology, the candidate should possess a first class or equivalent in the appropriate branch either at Bachelor's or Master's degree level".

(2) after rule 8, the following rule shall be added, namely:-

"9. Savings Nothing contained in these rules shall adversely affect the persons holding the post on the date of publication of these rules in the *Tamil Nadu Government Gazette*".

Amendment to the Tamil Nadu Government Servants' Conduct Rules

No. SRO-B 54/2021.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Government Servants' Conduct Rules, 1973.

AMENDMENT

In the said Rules, in rule 8, in sub-rule (1), in clause (c), for the expression "for more than a term subject to a maximum period of four years," the expression "for more than **two** terms subject to the maximum period of **five** years." shall be substituted.

Amendment to the Special Rules for the Tamil Nadu Secretariat Service

No. SRO-B 55/2021.-In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Secretariat Service (Section 29 in Volume-III of the Tamil Nadu Services Manual, 2016):-

AMENDMENTS

In the said Special Rules, in Annexure II referred to in rule 17,

(1) in rule 2, -

(i) in sub-rule (i), in the "TABLE", against the entry "2. Strictly Confidential Assistant Section Officers" in column (1), for the entry in column (2) thereof, the following entries shall be substituted, namely:-

"(i) By promotion from the category of Assistant Section Officers in the Departments of Secretariat other than Law and Finance Departments and the Governor's Secretariat.

(ii) By recruitment by transfer from the category of Special Branch Assistants and Special Assistants in the Tamil Nadu Ministerial Service.";

(ii) in sub rule (ii), for the second proviso, the following proviso shall be substituted, namely:-

"Provided further that the ratio for making appointment to the category of Strictly Confidential Assistant Section Officers by promotion from the category of Assistant Section Officers in the Departments of Secretariat other than Law and Finance Departments and the Governor's Secretariat in the Tamil Nadu Secretariat Service and by recruitment by transfer from the category of Special Branch Assistants and Special Assistants in the Tamil Nadu Ministerial Service shall be 8:1";

(2) after rule 3, the following rule shall be added, namely:-

"4. Qualifications.- No person shall be eligible for appointment to the category of Strictly Confidential Assistant

Section Officers by the methods specified in column (1) of the Table below unless he possesses the qualifications specified in the corresponding entries in column (2) thereof:-
