#### Special Rules for the Tamil Nadu Food Safety Service

[G.O. Ms. No.412, Health and Family Welfare (M1), 23rd September 2021, புரட்டாசி 7, பிலவ, திருவள்ளுவர் ஆண்டு-2052.]

No. SRO-B 56/2021.--In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Special Rules for the Tamil Nadu Food Safety Service, which shall form part as Section 55 in Volume - II of the Tamil Nadu Services Manual, 2016:-

2. The rules hereby made shall be deemed to have come into force on and from the 18th February 2015.

RULES

1. Constitution:- The Service shall consist of the following posts, namely:-

- (1) Chief Food Analyst.
- (2) Food Analyst.
- (3) Deputy Food Analyst.
- (4) Senior Analyst.

2. Appointment.- Appointment to the posts specified in column (1) of the Table below shall be made by the methods specified in the corresponding entries in column (2) thereof:-

(1)	Chief Food Analyst	By promotion from among the holders of the post of Food Analyst	
(2)	Food Analyst	By promotion from among the holders by the post of Deputy Food Analyst;

		By promotion from among the holders of the post of Senior Analyst, if no suitable and qualified persons are available in the post of Deputy Food Analyst;	
		(or)	
		By promotion from among the holders of the post of Microbiologist in the Tamil Nadu Food Safety Service; if no suitable and qualified persons are available in the above said two posts.	
(3)	Deputy Food Analyst	<i>(i)</i> By promotion from among the holders of the post of Senior Analyst;	
		(or)	
		<i>(ii)</i> By direct recruitment, if no suitable and qualified person is available by promotion.	
(4)	Senior Analyst	<i>(i)</i> By recruitment by transfer from the post of Junior Analyst in the Tamil Nadu Food Safety Subordinate Service; or	
		( <i>ii</i> ) by direct recruitment, if no suitable and qualified person is available by recruitment by transfer.

4. Qualifications - (a) Age- No person shall be eligible for appointment to the posts by Direct recruitment, if he has completed or will complete the age of thirty years on the first day of July of the year in which the vacancy is notified.

(b) Other Qualifications - No person shall be eligible for appointment to the posts specified in the column (1) of the Table below by the method specified in the corresponding entries in column (2) thereof, unless he possesses the qualifications specified in the corresponding entries in column (3) thereof:-

**5.** *Reservation of Appointment* - The rule relating to reservation of appointment (General Rule 22) shall apply for appointment to the posts by direct recruitment:

Provided that with effect on and from the 15th September 2016, the provisions contained in Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) shall apply for appointment to the posts by direct recruitment.

6. *Probation* - Every person appointed to the post by direct recruitment shall, from the date on which he joins duty be on probation, for a total period of two years on duty within a continuous period of three years:

Provided that every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty be on probation for a total period of one year on duty within a continuous period of two years.

7. Preparation of annual list of approved candidates - For the purpose of preparation of the annual list of approved candidates for appointment to the posts either by promotion or by recruitment by transfer, the crucial date on which the candidate should have acquired the prescribed qualifications shall be the 15th February of every year.

8. Test - Every person appointed to the post by direct recruitment shall pass Account Test for Executive Officers within the period of probation.

If the person appointed to the above said post does not pass the above tests within the period of his probation, he shall not be allowed to draw his second and subsequent increments until he passes the tests. Such ineligibility to draw increments shall not have the effect of postponing his future increment after he passes the test.

9. Saving - Nothing contained in these rules shall adversely affect any person holding the posts as on the date of issue of these rules.

2. The amendment hereby made shall be deemed to have come into force on and from 5th May 2010.

"(i) Promotion from Associate Professors in Engineering subjects in Engineering Colleges; or

(ii) Direct recruitment".
