Each member of the Senate shall have a right to nominate not more than one person who is not a member of any of the authorities of the University to the Search Committee.

Every nomination shall be in writing signed by the proposer who shall be a member of the Senate and seconded in writing by another member of the Senate called the seconder in the prescribed form. The nomination paper and consent of the nominee may be downloaded from this University website. No nomination shall be valid unless it contains the signatures of both the proposer and the seconder and the nomination form shall also be signed by the person proposed expressing his/her consent to be nominated. Every nomination must be presented before the Registrar either by the proposer or by the seconder or by the person proposed, **before 3.00 p.m. on Friday, the 10th December 2021.**
