Amendments to the Special Rules for the Tamil Nadu General Service.

[G.O.Ms.No. 11, Personnel and Administrative Reforms (C), 3rd February 2021, தை 21, சார்வரி, திருவள்ளுவர் ஆண்டு–2052./

No. SRO B-6/2021.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tarnil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu General Service (Section 16 in Volume 11 of the Tamil Nadu Services Manual, 2016):-

2. The amendments hereby made shall be deemed to have come into force on the 1st October 2018.

AMENDMENTS

In the said Special Rules, in Class XII - A, in rule 2, for sub-rule (ii) and the proviso thereto, the following sub-rule shall be substituted, namely:-

"(ii) Must have undergone the Compulsory Class-room and City Offices Training for a period of not less than three months (thirteen weeks) in the category of Under Secretary to Government:

Provided that those who have undergone Compulsory District Training in the category of Under Secretary to Government prior to 1st October 2018 shall be eligible for promotion as Deputy Secretary to Government."

Amendments to the Tamil Nadu leave Rules, 1933.

[G.O.Ms.No. 12, Personnel and Administrative Reforms (FR.II), 8th February 2021, தை 26, சார்வரி, திருவள்ளுவர் ஆண்டு–2052.]

No. SRO B-7/2021.— In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Leave Rules, 1933 contained in Annexure-III to the Fundamental Rules.

2. The amendment hereby made shall be deemed to have come into force on the 27th April 2020.

AMENDMENTS

In the said Tamil Nadu Leave Rules, 1933, to rule 7A, the following provisos shall be added, namely:-

"Provided that the surrender of earned leave for encashment is suspended for a period of one year from the 27th April 2020:

Provided further that all surrender requests and bills pending on the said date irrespective of their stage of sanction of disbursement shall not be processed. In cases where sanction orders have been issued, they shall be cancelled and earned leave re-credited to the leave account of the Government servant." .

Amendments to the Special Rules for the Tamil Nadu Survey and Land Records Subordinate Service.

No. SRO B-8/2021.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Survey and Land Records Subordinate Service.

2. The amendment hereby made shall be deemed to have come into force on the 3rd October 2005.

AMENDMENTS

In the said Special Rules, in rule 2, in the tabular column, under the sub-heading class II in column (1), for the entries in column (2) against the entries "Category 7 Draftsman" in column(I), the following entries shall be substituted; namely:-

- "1. By promotion from Typographer Grade-II; or
- 2. By transfer from category 4 in class I or
- 3. If no qualified and suitable candidate is available for such promotion and transfer, direct recruitment:

Provided that every Field Surveyor (Category 4 in Class I) or Typographer, Grade II (Category 8 in Class II) shall at the time of preparation of list of persons eligible for appointment as Draftsman, exercise an option as to the line in which he desires to continue and that the option once exercised shall be final".
