Recruitment Rules for the Posts of Senior Mechanic Gr-I, Chargeman (Mechanical) and Operator Gr-I (Class- III)

Amendment to the Schedule II of Tuticorin Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2017.

In exercise of the powers conferred by sub-section (i) of Section 124, read with sub-section (1)(a) of the Major Port Trusts Act, 1963 (38 of 1963) the Board of Trustees, V.O. Chidambaranar Port Trust hereby approves the revised manner of recruitment (Recruitment Rules) for Class-III posts under Regulation 5 of Tuticorin Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2008 as set out in the Schedule annexed to this Notification.

2. The said Recruitment Rules shall come into effect from the date of publication of this Notification in the *Tamil Nadu Government Gazette*.

SCHEDULE

(1) In the said Schedule under Regulations, in the Recruitment Rules for the post of Senior Mechanic Gr-I (Mechanical & Electrical Engineering Department) (SI.No.115), the provisions under Column No.12 shall be substituted by the following-

Promotion:

Senior Mechanic with five years regular service in the grade under the scheme of skilled scales subject to passing the trade test prescribed and conducted by the Port, failing which senior Mechanic with 10 years regular service put together in the grades of Senior Mechanic and Mechanic/ Assistant Mechanic / Blacksmith /Auto Electrician / Welder in the Port subject to passing the trade test prescribed and conducted by the Port.

(2) In the said Schedule under Regulations, in the Recruitment Rules for the post of Chargeman (Mechanical) of (Mechanical & Electrical Engineering Department) (SI.No.94), the provisions under Column No. 12 shall be substituted by the following:-

Promotion:

Assistant Chargeman (Mech) with 5 years regular service failing which Sr. Mechanic / Sr. Fitter / Sr. Platter / Operator Special Grade with 5 years regular service in the grade in the port.

(3) In the said Schedule under Regulations, in the Recruitment Rules for the post of Operator Gr-I of (Mechanical & Electrical Engineering Department) (SI.No.101), the provisions under Column No.12 shall be substituted by the following:-

Promotion:

- (i) Operator Grade II with three years regular service in the grade in the port.
- (ii) Should pass the trade test prescribed and conducted by the port
