## Amendment to the Tamil Nadu Public Service Commission Regulations.

[G.O. Ms. No. 38, Human Resources Management (M), 26th April 2022, சித்திரை 13, சுபகிருது, திருவள்ளுவர் ஆண்டு–2053.]

No. SRO B-29/2022.—In exercise of the powers conferred by the proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Public Service Commission Regulations, 1954 (Volume-I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 1st August 2018.

#### AMENDMENT.

In the said Regulations, in regulation 16, in clause (b), the following proviso shall be added, namely:-

"Provided that in respect of matters relating to regularizing the services of the individuals appointed under compassionate grounds, the Commission shall not be consulted."

#### Amendment to Special Rules for the Tamil Nadu Secretariat Service.

[G.O. Ms. No. 39, Human Resources Management (D), 28th April 2022, சித்திரை 15, சுபகிருது, திருவள்ளுவர் ஆண்டு–2053.]

No. SRO B-30/2022.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Secretariat Service (Section 29 in Volume-III of the Tamil Nadu Services Manual, 2016):-

2. The amendment hereby made shall be deemed to have come into force on the 1st August 2020.

#### AMENDMENT.

In the said Special Rules, in rule 14, in the "TABLE", against the entry "Category 3(d) Assistants in Finance Department" in column (1), for the entry "Recruitment by transfer from the post of Record Assistant or Record Clerk in the Tamil Nadu General Subordinate Service or Office Assistant in the Tamil Nadu Basic Service" in column (2) and the corresponding entries (i) and (ii) in column (3) thereof, the following entries shall, respectively, be substituted, namley:-

"Recruitment by transfer (i) from the post of Record Assistant or Record Clerk in the Tamil Nadu General Subordinate Service

A Bachelor's Degree in Commerce or Economics or Statistics :

Provided that a Record Assistant or Record Clerk already in service in Finance Department or any other Department of the Secretariat, who has not acquired the above qualification as on 07.10.1998, shall also be eligible for appointment as Assistant in the Finance Department.

(ii) Service for a period of not less than five years in the category of Record Assistant or Record Clerk in Finance Department or any other Department of Secretariat:

Provided that a Record Assistant or Record Clerk, irrespective of the method of appointment by which he has been appointed as such, who holds a Bachelor's Degree in Commerce or Economics or Statistics shall be eligible for appointment as Assistant after satisfactory completion of his probation and possessing three years of service, either before or after acquiring the Degree.

Recruitment by transfer (i) from the post of Office Assistant in the Tamil Nadu Basic Service

A Bachelor's Degree in Commerce or Economics or Statistics :

Provided that an Office Assistant already in service in Finance Department or any other Department of the Secretariat, who has not acquired the above qualification as on 07.10.1998, shall also be eligible for appointment as Assistant in the Finance Department.

(ii) Service for a period of not less than five years in the category of Office Assistant in Finance Department or any other Department of Secretariat."
