by a resolution of the Council subject to approval of the Government, even after he attains 62 years of age or even after the completion of 2 years after the age of superannuation ordered by the Government from time to time.

25-B. Applications, if any, for extension shall be made by the employee sufficiently early and subject to his being physically and otherwise fit, the Council shall not, grant extension of service, to any employee for more than a year at a time and not more than two such extensions shall be given to an employee under any circumstances, *i.e.*, beyond the date on which he attains the 64 years of age or 4 years after the age of superannuation ordered by the Government from time to time".
