"WARNING TO ROAD USERS"

It is notified for information of the public that in connection with introduction of 25 kV ac electric traction on the newly laid track, as part of doubling (i) between Milavittan (Exclusive) and Tuticorin (Inclusive) Stations from OHE Mast Location No.646/23 (km/ch:646/574.70) to OHE Mast Location No. 653/48 (km/ch:653/1006.00) and (ii) between Valliyur (Exclusive) and Tirunelveli Jn (Inclusive) Stations from OHE Mast Location No.322/22 (km/ch: 322/595.50) to OHE Mast Location No. TEN/1002 (Km/Ch:27/22.30) at 25kV AC single phase 50Hz supply system on Madurai-Tuticorin and Nagercoil-Tirunelveli Sections in Madurai and Thiruvananthapuram Divisions of Southern Railway, height gauges have been erected at all the level crossings with clear MAXIMUM HEIGHT OF 4.78m above road level with a view to prevent loads of excessive height from coming into contact or in dangerous proximity to live traction wire (CONTACT WIRE), WHICH SHALL BE AT A HEIGHT OF MINIMUM 5.5m ABOVE THE RAIL LEVEL AT LEVEL CROSSINGS.

Public are hereby notified to observe the height specified above for the purpose of loading vehicles and to see that the loads carried in road vehicles do not infringe the height gauges under any circumstances,.

The dangers of a load of excessive height are as follows:

- (i) Danger to the height gauge and consequent obstruction to the road as well as the railway line.
- (ii) Danger to the materials or equipment carried or for the vehicle itself.
- (iii) Danger of fire and risk of life due to contact with or in dangerous proximity to the conductors.
