No. SRO B-35/2022.—In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendments to the Fundamental Rules.

2. (i) The amendment (i) hereby made shall be deemed to have come into force on the 7th May 2020.
(ii) The amendment (ii) hereby made shall be deemed to have come into force on the 25th February 2021.

AMENDMENTS

In the said Fundamental Rules, in Rule 56, in sub-rule (3), in clause (d), in sub-clause (i), in the Table,-

(i) under the heading "weightage with reference to age", in column (2), under the sub-heading "For all the Government servants other than the Government servants in the Tamil Nadu Basic Service.-" for the expressions in column (a) under the heading "Age" and the corresponding expressions in column (b) under the heading "weightage" thereof, the following expressions shall, respectively, be substituted, namely:-

54 years and below	5 years of weightage
55 years	4 years of weightage
56 years	3 years of weightage
57 years	2 years of weightage
58 years	1 year of weightage

(ii) for the heading "weightage with reference to age" in Column (2) and all the sub-headings and expressions thereunder, the following heading and the expressions shall be substituted, namely:-

No. SRO B-36/2022.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules in Class XXII of the Tamil Nadu General Subordinate Service (Section 13 in Volume III of the Tamil Nadu Services Manual, 2016).

2. (i) The amendment (1) hereby made shall be deemed to have come into force on the 21st September 1999.
(ii) The amendment (2) hereby made shall be deemed to have come into force on the 15th September 2016.

AMENDMENTS

In the said Rules, in rule 8,—

(1) after the expression "by direct recruitment" at the end, the expression "in which the cadre strength is more than one under the jurisdiction of each appointing authority" shall be added;

(2) for the expression "The rule of reservation of appointments (General Rule 22)", the expression "The principle of reservation of appointments as provided in Section 27 of Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016)" shall be substituted.
