#### Framing of Adhoc Rules to the Temporary post of Senior System Analyst in the Special Programme Implementation Department in Tamil Nadu General Service.

[G.O. Ms. No. 2, Special Programme Implementation (OP), 14th February 2022, மாசி 2, பிலவ, திருவள்ளுவர் ஆண்டு–2053.]

No. SRO B-46/2022.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following Rules:-

2. The Rules hereby made shall be deemed to have come into force on the 17th July, 2020.

#### RULES

The Tamil Nadu Government servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent posts in Class XII of Tamil Nadu General Service shall apply to the holders of the temporary post of Senior System Analyst in the Special Programme Implementation Department, sanctioned from time to time, subject to the modifications specified in the following rules:-

2. Constitution.- The post shall constitute a distinct category in the said Class in the said service.

3. Appointment.- Appointment to the post shall be made as follows:-

(i) by promotion from among the holders of the post of System Analyst in the Special Programme Implementation Department; or

- (ii) by recruitment by transfer from any other service; or
- (iii) by direct recruitment

**4. Appointing Authority.-** The appointing authority for the post shall be the Secretary to Government, Special Programme Implementation Department.

5. Qualifications: (a) Age.- No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete the age of thirty years on the first day of July of the year in which the vacancy is notified.

(b) Other Qualifications.- No person shall be eligible for appointment to the post unless he possesses the qualifications specified below:-

Method of Appointment	Qualification

By promotion (or) by recruitment by transfer (or) by direct recruitment	B.E. / B.Tech. Computer Science or Information Technology or MCA or Msc (IT) with experience for a period of not less than five years in Software

**6.** Reservation of appointment.- Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) relating to reservation of appointment shall apply for appointment to the post by direct recruitment.

7. Probation.- (a) Every Person appointed to the post by direct recruitment shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

(b) Every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuous period of two years.

8. Preparation of annual list of approved candidates.- For the purpose of preparation of annual list of approved candidates for appointment to the post the crucial date shall be the 1st September of every year.

9. Pay.-There shall be paid to the holder of the post, a monthly pay calculated in the level of pay 25 of Rs.59300 -187700/-.
