Class II - Other Members - Sub-Sec. (b) (2) of Section 24 under Chapter IV of the Bharathidasan University Act, 1981 - Two Members elected by teachers of affiliated colleges, other than the Principals, from among themselves, who are the members of the Senate in accordance with the system of proportional representation by means of a single transferable vote.

FILLING OF CASUAL VACANCY:

Section 47 under Chapter X of Bharathidasan University Act, 1981 (Tamil Nadu Act 2 of 1982).

The total number of vacancy in the Syndicate is one (Residual Vacancy). The membership of the another member in the Syndicate continues, as on date.

The tenure of office is upto 22.01.2024 from the date of declaration of the result of the election.

In this connection, nomination is invited in the prescribed form which can be obtained from the Registrar and Returning Officer on a requisition and submission of a **Demand Draft for Rs.590/- (Including GST - Five Hundred and Ninety only) drawn in favour of Bharathidasan University, Tiruchirappalli** on or after the date of notification, i.e. **30.09.2022** with a stamped self-addressed envelope to the value of Rs.25/- (Rupees twenty five only) or in person.

Nomination paper shall be enclosed in an envelope superscribed as follows, as the case may be:-

"NOMINATION FOR ELECTION TO THE SYNDICATE - BY THE TEACHERS OF AFFILIATED COLLEGES OTHER THAN PRINCIPALS FROM AMONG THEMSELVES \ WHO ARE MEMBERS OF THE SENATE"

The Members are requested to send their nomination by Registered Post (with Acknowledgement due) so as to reach the Registrar and Returning Officer within the date and hour fixed or delivered to the Registrar and Returning Officer either in person or by a messenger within the date and hour fixed.

Nomination papers that are not sent as stated above will be declared invalid.
