BOUNDARIES.

North.—The boundary starts from the tri-junction point Survey Number.695 part, 857 and 869 of Village No. 93, Sirumalai Village and runs towards eastern direction along with the southern boundary of Survey Number. 857, turn towards north and runs towards northern direction along with the eastern boundary of Survey Number. 857 and reached the quadra junction point of Survey Numbers. 869, 857, 691/7 and 691/8 of Village No.93 Sirumalai Village. Thence this boundary turns towards west and runs towards western direction along with the northern boundary of Survey Number. 857 and reaches the tri-junction point of Survey Numbers. 691/9, 691/7 and 857 of 93 Sirumalai Village. This boundary thence turns towards north and travels towards northern direction along with the eastern boundary of Survey Number. 691/9 turns towards east and travels towards eastern direction along with the southern boundary of Survey Number. 691/9 turns towards east and travels towards eastern direction along with the southern boundary of Survey Number. 691/3A2 till it reaches the tri-junction point of Survey Numbers. 869, 691/7 and 691/3A2 of 93 Sirumalai Village. Thence this boundary turns towards north and runs towards northern direction along with the eastern and southern boundary of 691/3A2 till it reaches the tri-junction point of Survey Numbers. 691/3A2, 691/10 and 868 of 93 Sirumalai Village. Thence this boundary turns towards east and runs towards eastern direction along with the southern and western boundary of Survey Number.

691/10 reaches the tri-junction point of Survey Numbers. 691/10, 783 and 868 of 93 Sirumalai Village.

East.— Thence this boundary runs towards southern direction along with the western boundary of Survey Number.783 and reaches the tri-junction point of Survey Numbers.771, 868 and 783 of 93 Sirumalai Village. Thence this boundary generally turns towards west and travels towards western direction along with the north and west boundary of Survey Number.771 till it reaches the tri-junction point of Survey Numbers.771, 876 and 869 of 93 Sirumalai Village. Thence this boundary generally turns towards East and runs towards Eastern direction along with the southern boundary of Survey Number 876 and reaches the tri-junction point of Survey Numbers.876, 777 and 869 of 93 Sirumalai Village. Thence this boundary generally turns towards south and travels towards southern direction along with the western boundary of Survey Number.777 till it reaches the tri junction of Survey Numbers.869, 777 and 1234 of 93 Sirumalai Village. Thence this boundary generally turns towards west and travels towards western direction along with the north and west boundary of Survey Number.1234 and reaches the quadra junction point of Survey Numbers.869, 1234, 1233 and 1232 of 93 Sirumalai Village.

South.— Thence this boundary generally turns towards west runs towards western direction along with the northern boundary of Survey Numbers.1232, 1231, 1230, 1229 till it reaches the tri-junction point of Survey Numbers.869, 1229 and 695 part of village No.93 Sirumalai Village. Thence this boundary turns towards western direction along with the northern boundary of Survey Number.695 part till it reaches the junction point of Survey Number.869 and 695 part.

West.— This boundary generally turns towards north and travels towards northern direction along with the western boundary of Survey Number.695 part and reaches the origin point.

ADMITTED RIGHTS:

Right No.1 - Odai: There is Odai within the four boundaries in the proposed Sirumalai West Forest Block-I (Bit II). A part of this Odai starts from the western boundary of Survey Number.777 of Village No.93, Sirumalai Village and runs from east to west in Survey Number.869 of the proposed Reserved Forests. An another part of the Odai starts from the southern boundary of Survey Number.857 travels from north to the east direction from the western part of Survey Number.869 and joins with the other Odai near the boundary of Survey Number.695 part at the southern side and passes through Survey Number.695 part of Village No.93 Sirumalai Village. This Odai has been in existence even prior to the publication of preliminary notification under section 4 of The Tamil Nadu Forest Act, 1882.

Therefore permission has been granted to the existing Odai without any modification in its direction and the public were permitted to utilise the Odai in its direction in *Suo-moto* claim No.592/2009 dated 06.08.2009 of the Forest Settlement Officer, Dindigul.

Right No.2 - Cart Track-1: A cart track width 3.0 meter starts from the junction point of southern boundary of Survey Number.876 and northern boundary of Survey

Number.869 of Village No.93. 'Sirumalai and runs towards southern direction via Route No.1 from the distance 72.0 meter and travels southern direction to a distance of 159.0 meter, slightly turns towards west and runs towards south western direction, then travels towards southern direction, then slightly diverts and travels south western direction then travels towards southern direction and reaches the junction of southern boundary of Survey Number.869 and northern boundary Survey Number.1231. The length of this Cart Track is 898.6 meter.

Right No.3 - Cart Track No.2: There is a cart track width 3.0 meter starts from the junction point of southern boundary of Survey Number 876 and northern boundary of Survey Number.869 of No.93, Sirumalai Village runs towards southern direction to a distance of 72.0 meter turns towards west and runs towards south western direction, then turn towards west runs towards north western direction southern direction, then slightly diverts and travels south western direction upto Karuppu Kovil. The length of this Cart Track is 1919.3 meters. The Magnetic bearing and the distance of this Cart Track in the proposed Sirumalai West Forest Block-I Bit II as follows:-
